I ASI Prashanta Bardhan of Enforcement Branch Slliguri Police Commissionerate do hereby lodge this written complaint against the Hotel owner namely Sefali Barman (38) W/O Kartik Barman of Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling hotel styled as "Barman Hotel" at Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling who was illegally procured domestic Indene gas cylinder and using the domestic Gas cylinder at his Hotel styled as "Barman Hotel" situated at Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling for commercial purpose without any valid documents or license, to the effect that foday i.e. 30.07.21 at 10'05 hrs I received an information from reliable source that one Sefali Barman (38) W/O Kartik Barman of Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling styled as "Barman Hotel", at Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling has been using the domestic Gas cylinder at her Hotel for use commercial purpose for her wrongful gain.

As per direction of ACP Enforcement Branch, SPC I, along with SI Pradip Chakraborty ,SI Goutam Kundu, , C/424 Manik Roy , L/C 1270 Deeptina Gazmer of EB SPC left for Pradhannagar PS vide EB SPC M.C.C No 92 /21 Dt.30.07.2021 with investigation kit. The matters informed to Pradhannagar PS vide Pradhannagar PS GDE No. 1863 /21 Dated 30/07/2021 along. with K -31 Mobile van SI R.N Sarkar, , CV-993 Anil Das of Pradhannaghar PS had been to Bandri Jote near Panchanadi Bridge, Dagapur, PSshannagar, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure if required and on reaching at Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling we contacted with source and being shown and identify by the source. I along with officers and force entered into Hotel styled as "Barman Hotel" of Sefali Barman (38) W/O Kartik Barman of Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling. I found that they are preparing foods at Hotel by using the Indene IOC domestic Gas cylinder without any valid documents for commercial use on demand they could not produce any valid documents in support of using the Indene IOC cylinders for commercial use. On seeing the Police party the sheep owner namely Sefali Barman fled away from the shop to avoid police arrest. Further local enquiry it is revealed that the above noted accused person was using the domestic Indene1 IOC Gas cylinder for preparing food at his Hotel as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Ashish Choudhury (45) C/O Lt. Narayan Choudhary of Bandri Jote, PS- Pradhannagar, Dist- Darjeeling and (2) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the shop Sefali Barman used the domestic Indene cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from the possession of her husband namely Kartik Barman of Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling after preparing proper seizure list and label .The seizure was made in between 12'05 hrs to 12'35 hrs.

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Sefali Barman (38) W/O Kartik Barman of Bandri Jote near Panchanadi Bridge, Dagapur, PS- Pradhannagar, Dist- Darjeeling and arrange for its investigation.
