

Sir,

In producing here with four arrested persons namely, (1) Ashim Sarkar(25) S/O Lt. Atul Sarkar of near Natun Bridge Sarnagar, Ps. Pradhan Nagar, Dist-Darjeeling, (2) Sanjoy Pradhan (19) @ Santu S/O Lt. Mani Pradhan of Lohasingh MATH, Battala Samar Nagar, Ps. Pradhan Nagar, Dlg (3) Rahul Hossain @ Daku (19) Battala Ganga Mandir, Ps. Pradhan Nagar/Dlg, (4) Hari Singh (30) S/O Lt. Labon Singh of Middle Palash, Debidanga, Ps. Pradhan Nagar/Dlg along with seized articles (i) One Iron Hammar, (ii) One Iron Rod one side sharp point length measuring 14" inch (iii) One iron 'Daa' measuring iron part 8" inch & wooden but measuring 4" inch, (iv) One Iron 'Kanchi' with wooden but iron part measuring approx 9" inch length & butt measuring approx 5" inch along with seizure list and connected papers.

I ASI. Ashit Singha of Pradhan nagar Ps/SPC do here by lodged the complaint against the above miscreants that, Today i.e. 30.07.21 22:15hrs. received an information from credible source that 10/12 miscreants armed with deadly weapons assembled below Mahananda Bridge, Champasari under Pradhan Nagar Ps and preparing themselves to commit 'Dacoity' at Baghajatin Colony under Pradhan nagar Ps area against property and vehicle. After receiving this information I informed the matter to on duty officer as well as I/C Pradhan Nagar PS. The On Duty Officer diarized the information in GDE vide Pradhan Nagar PS GDE No- 1917, Dated- 30.07.21 and as per direction of I/C Pradhan Nagar PS myself along with force, ASI. Ratan Pradhan, Cv645 Pankaj Gupta, CV 223 Swapan Chetri proceeded to the place to work out the information, I also informed the R.T. Mobile Officer to assist us. R.T. Mobile Officer ASI. Suresh Kami and Const/476 Jagat Ch. Roy proceeded for assisting us.

At about 22:35 hrs we reached near Champasari Mahananda Bridge and met with my source there and he corroborated the information again. Afterwards we proceeded towards the spot on foot and we found 10/12 persons were sitting below Mahananda Bridge and seeing the uniformed police party they tried to flee away but we apprehended 04 (four) persons out of them and the apprehended persons disclosed the identity of themselves as, (1) (1) Ashim Sarkar (25) S/O Lt. Atul Sarkar of near Natun Bridge Sarnagar, Ps. Pradhan Nagar, Dist-Darjeeling, (2) Sanjoy Pradhan (19) @ Santu S/O Lt. Mani Pradhan of Lohasingh MATH, Battala Samar Nagar, Ps. Pradhan Nagar, Dlg (3) Rahul Hossain @ Daku (19) Battala Ganga Mandir, Ps. Pradhan Nagar/Dlg, (4) Hari Singh (30) S/O Lt. Labon Singh of Middle Palash, Debidanga, Ps. Pradhan Nagar/Dlg along with 6/7 other miscreants who managed to flee away. After their apprehension we have disclosed our identity to them as the officer and men of Pradhan Nagar PS. On being asked they disclosed that they assembled there and preparing them to commit Dacoity at Baghajatin Colony under this Ps. Then after observing all formalities I conducted search of the apprehended persons. During search, I found in the possession of accd (1) Ashim Sarkar (25) along with seized articles sl no. (i) One Iron Hammar, accd. (2) Sanjoy Pradhan (19) sl no. (ii) One Iron Rod one side sharp point length measuring 14" inch, accd (3) Rahul Hossain @ Daku sl no. (iii) One iron 'Daa' measuring iron part 8" inch & wooden but measuring 4" inch, accd. (4) Hari Singh (30) sl no. (iv) One Iron 'Kanchi'. On demand the apprehended persons failed give any satisfactory answer for possessing those illegal weapons in the darkness and presence. Those were seized from their possession in between 23:05 hrs to 23:35 hrs under proper seizure list duly signed by the police witnesses as no public witness available there at that time of night. The seized articles were also labeled and sealed on the spot and arrested the above noted apprehended persons namely at 23:45 hrs after observing all norms of NHRC and Hon'ble

Supreme Court of India for possessing illegal weapons and preparation of Dacoity, issuing Memo of Arrest after that conducted raid in criminal den and adjacent area to apprehend the other associates leading to their statements. Then I brought the accused persons to Pradhan Nagar PS and produce before duty officer along with all seized articles and relevant papers.

So, I therefore pray before you that a case U/S- 399/402 IPC may kindly be started against the miscreants namely (1) Ashim Sarkar(25) S/O Lt.Atul Sarkar of near Natun Bridge Sarnagar,Ps.Pradhan Nagar,Dist-Darjeeling,(2) Sanjoy Pradhan (19) @ Santu S/O Lt.Mani Pradhan of Lohasingh Math ,Battala Samar Nagar,PS.Pradhan Nagar,Djg(3) Rahul Hossain@ Daku(19)Battala Ganga Mandir,Ps.Pradhan Nagar/Djg,(4)Hari Singh(30) S/O Lt.Labon Singh of Middle Palash,Debidanga,Ps.Pradhan Nagar/Djg along with 6/7 other miscreants and arrange for its investigation.
