Sir,

With due respect, I LPSI Supriya Barman of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely i) Munna Kherwar 40yrs s/o Late Ram Kherwar of Kalkata Road Bhujlapani PS, Bagdogra Dist, Darjeeling ii) Siman Oraon 27yrs s/o Late Sukumar Oraon of Kadopani PS, Bagdogra Dist, Darjeeling iii) Arjun Kherwar 35yrs s/o Late Shiv Charan Kherwar of Kadopani PS, Bagdogra Dist, Darjeeling iv) Roshan Kujur 19 yrs s/o Roman Kujur of Kadopani PS, Bagdogra Dist, Darjeeling v) Arjun Das 56yrs s/o Ruplal Das of Khudirampolly PS, Bagdogra Dist, Darjeeling vi) Dhiraj Bhujel 39yrs s/o Gore Bhujel of Masjidpara PS, Bagdogra Dist, Darjeeling vii) Sanjit Kr Singha 31yrs s/o Late Samar Nath Singha of Pradhannagar PS, Bagdogra Dist, Darjeeling viii) Nandan Singh 33yrs s/o Biswanath Singh of Pradhannagar PS, Bagdogra Dist, Darjeeling ix) Nabin Roy 30yrs s/o Baldeb Roy of Pradhannagar PS, Bagdogra Dist, Darjeeling for disobeying Government order vide Memo no 486/CS/2021 dated 24.04.2021 and order No 647-ISS/2M-22/2020 dated 15.05.2021.

The facts of the case in brief is that today on 30/07/2021 at about **18.45 hrs** in course of evening special checking duty vide Bagdogra PS GDE No 1677 Dated 30/07/2021 the above noted persons were roaming unnecessary at **Bihar more** and adjacent area also they did not wear face mask as the Government of West Bengal has issued various order vide Memo no 486/CS/2021 dated 24.04.2021 that wearing of facial mask and maintain social distance made mandatory in public places in the current pandemic disaster situation all persons are to strictly comply with the COVID-19 safety norms vide order No 647-ISS/2M-22/2020 dated 15.05.2021 in terms of the provisions under Disaster Management Act 2005 read with West Bengal Epidemic Disease, Covid-19 Regulations 2020 unnecessary movement shall be strictly prohibited. Accordingly, I stop them and ask to reason for not wear of face mask and roaming unnecessary but they could not give any satisfactory reason also violate against our police party. It is pertinent to note here that since the outbreak of Second wave of Corona Virus awareness regarding wearing of face mask and maintain of social distancing had been conducted through miking but the above noted persons had no botheration regarding their own safety and also the safety of others. Their act is dangerous so as to the spread of Corona Virus. Thereafter, I tried to convince them and directed to wear face mask but they denied to do so and started arguing with me. Finding no other alternative way, I apprehended them to avoid risks to human life and health.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
