Accordingly, I seized the above noted illicit liquor found under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest also inform him ground of his arrest. The whole process of seizure and labelled was made in between 20.35 hrs to 21.15 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Kartik Dey 41yrs s/o Kalipada Dey of Putimari Gosainpur PS, Bagdogra, Dist- Darjeeling and arrange for its investigation.
