In producing herewith the three arrested accused persons namely 1) Humayan Kabir 25 yrs (D/B 1991) s/o Md Amiruddin vill: Tarijote PO, New Rangia PS, Matigara Dist- Darjeeling ii) Sunney Rai 35 yrs (D/B 1986) s/o Kumar Rai of Gangtok Municipal Corporation Lower Sichey Lingding near Lingding Govt, Jr H.S Lower Sichey PS, Sardar Dist, East Sikim iii) Smt Heena Rai 28yrs W/O Sunney Rai of Gangtok Municipal Corporation Lower Sichey Lingding near Lingding Govt, Jr H.S Lower Sichey PS, Sardar Dist, East Sikim A/P Shibmandir near NBU gate under Matigara PS, along with following seized articles viz:

- (1) One zipper transparent thin plastic packet wrapped in a part of Bengali news paper styled as "Uttar Banga Sombad" on dated 29th July 2021 which contains 75 grams brownish powder believe to be "Brown Sugar" and marked as Exhibit 'A' and out of which 10 Grams believe to be "Brown Sugar" randomly taken as sample in transparent thin zipper plastic packet from the mother packet Exhibit "A" and marked as Exhibit -"A-1"
- (2) One Four Wheeler Car styled as Alto blue color bearing registration no WB 74 BD/9513 with key.
- (3) One electronic battery small weighing machine without styled.
- (4) Indian currency Cash Rs, 85.000/= (Eighty five thousand) denomination of Rs, 500x170 pcs.
- (5) One green color hand bag brown & black belt without styled.
- (6) Three android Mobile hand set, a) One mobile hand set styled as Vivo-Y-55 having SIM no 9832423016 recovered from the possession of accd, Humayan Kabir b) One mobile hand set styled as Vivo having SIM no 8653330662 recovered from the possession of accd, Sunney Rai c) One mobile hand set styled as Oppo Model CPH-1937 having two SIM vide no 9832423016 8436166002, 8250001065 recovered from the possession of accd, Heena Rai.

I, SI Dipankar Chakraborty of Bagdogra PS, Siliguri police Commissionerate lodge a written complaint to the effect that on 31.07.2021 at about 14.15 hrs received a reliable source information that three persons are coming including one lady from Islampur side by a four wheeler styled as Alto blue color bearing registration No. WB 74 BD/9513 towards Bagdogra Side through NH-31 road and they possess huge quantity of illegal narcotic substances Brown Sugar for selling the same to their designed customers at and around Shibmandir and Siliguri area for their wrongful gain very soon they reached near Airport approach more. Accordingly, the matter was diarized vide Bagdogra PS, SPC GDE No 1732 Dt- 31.07.2021. Accordingly informed to the O/C Bagdogra PS, and superiors as per under the provision of Law.

At about 14.20 hrs as per direction myself accompanied with you along with LPSI Supriya Barman, ASI Dharendra Nath Mandal, ASI Jakirul Islam, C/410 Mantosh Singh, CV/389 Janak Singha, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/375 Jogesh Barman, CV/378 Dipu Singha, CV/386 Kishor Ranjan Howlader all of Bagdogra PS, Siliguri Police Commissionerate left for Airport approach more under Bagdogra Police station with Govt (hired) to verify the authenticity of the information. This refers to Bagdogra PS, M.C.C. No 1491/2021 Dtd, 31.07.21 and GDE No. 1733 dated 31.07.21. At the time of departure from Police Station I bring spring weighing clock, small balance with stone,

envelope, paper, sealing wax, gum, seal etc on way to spot at Airport approach More meanwhile, under this circumstance any search warrant or authorization cannot be obtained for not affording opportunity for the concealment of evidence or facility for the escape of the offender.

At around 14.35 hrs, I along with officers and force accompanied with OC, Bagdogra PS, reached at near Airport approach More, under Bagdogra PS, and started special checking in a convenient place keeping watch on the blue color Alto four wheeler car bearing registration No. WB 74 BD/9513 coming from Islampur side. In course of special Checking, at around 14.50 hrs one blue color Alto four wheeler car bearing registration No. WB 74 BD/9513 was found to coming through the road i.e NH-31 and on being identified by the source, we signaled the said blue color Alto four wheeler car bearing registration No. WB 74 BD/9513 to stop but seeing the police party, the driver of vehicle tried to flee away from the spot, but somehow we managed to detained the said vehicle at Airport approach more under Bagdogra Ps and found that two persons sitting on the back side of said of car out of one female aged approx 25 yrs and front side one male person driven the said vehicle seeing their activities there is a strong reason to believe that they were possess something illegal on their possession and the blue color Alto four wheeler car bearing registration No. WB 74 BD/9513.

Accordingly, I disclosed my identity to them on demand they disclosed their name and identities as noted above. In the mean time, I called two disinterested independent witnesses namely 1] Mukhsud Ali 28yrs s/o Zakir Ali of Bhuttabari PS Bagdogra Dist- Darjeeling 2] Sri Raju Singha 25yrs s/o Boren Singha of Abhiram Jote Bhuttabari PS Bagdogra Dist: Darjeeling and disclosed them our name and identities and also share the information in writing also requested them to accompany us and remain present as independent witnesses during the time of search and seizure if any they both agreed to remain with us. I also offered them to search me and my whole team physically and they declined to do the same. Then, I tried to contact with nearest Executive Magistrate i.e, the BDO of Naxalbari Block, Darjeeling over telephone but could not be contacted. Hence, I asked them whether they wanted to be searched in presence of any Executive Magistrate or Gazetted police officer then they agreed to be searched in presence of any of them. I served Notice individually u/s 50 NDPS Act in writing to them in accordance with the Provision of Law individually in this regard which they duly acknowledge by written respectively and again offered them to search the police party as per provision. Accordingly as per kind instruction of O/C Bagdogra PS, who was remain present with us in the spot at around 15.05 hrs, I send letter to Sri Santanu Tarafder ACP(AP) SPC, who had been detailed to act as Special Executive Magistrate of SPC for the day, informing him regarding the interception of the accused persons and suspected to be possessing huge quantity of believed to be Brown Sugar with the car and with a request him to come down at Airport approach more and remain present to supervise the search and seizure.

At about 16.10 hrs, Sri Santanu Tarafder ACP (AP) SPC, who had been detailed to act as Special Executive Magistrate of SPC for the day arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses and under his supervision then, I search the above noted two apprehended male persons observing all formalities and keeping their decency and while searching their possession i) One mobile hand set styled as Vivo-Y-55 having SIM no 9832423016 recovered from the possession of accd, Humayan Kabir (driver of the Alto car) kept on his pant front pocket ii) One mobile hand set styled as Vivo having SIM no 8653330662 recovered from the possession of accd, Sunney Rai which was kept on his pant front pocket out of three one female apprehended accd, Smt Heena Rai search under my direction by the LPS! Supriya Barman recovered one green colour ladies hand bag with brown & black stripe handle which was kept on her lap inside the bag containing one mobile hand set styled as Oppo Model CPH-1937 having two SIM vide no 8436166002,8250001065 along with one small electronic battery weighing machine without styled, cash Rs, 85,000/= (Eighty five thousand) denomination

of Rs. 85,000/- on interrogation about the cash the lady Smt Heena Rai stated that she went to Islampur to purchased NDPS substance "Brown Sugar" but the seller had no full fill her requirement for purchasing of contraband articles Brown Sugar hence the cash Rs. 85,000/- has been returned after purchasing 75 grams of NDPS substance of Brown Sugar. On further search and as per all three detain persons leading statement on search the blue color Alto four wheeler car bearing registration no. WB 74 BD/9513 back side from the luggage compartment one zipper transparent thin plastic packet wrapped in a part of Bengali news paper styled as "Uttar Banga Sombad" on dated 29th July 2021 which containing on weighing 75 grams brownish powder believe to be "Brown Sugar" and marked as Exhibit 'A' and out of which 10 Grams of brownish powder believe to be "Brown Sugar" randomly taken as sample in transparent thin zipper plastic packet from the mother packet Exhibit "A" and marked as Exhibit -"A-1" On demand the all three detained persons including lady personnel failed to produce any valid document in support of possessing of the suspected NDPS substance believe to be brown sugar accordingly, I seized all the above noted mentioned articles under proper seizure procedure and sealed, labelled mentioned above duly signed by them as well as the independent witnesses and acknowledge by the accused persons in presence of Special Executive Magistrate Sri Santanu Tarafder ACP(AP) SPC. The whole search seizure labelled procedure was made in between 16.15 hrs to 17.05 hrs in presence of Sri Santanu Tarafder ACP (AP) SPC, Special Executive Magistrate on the day.

On further interrogation, the above noted arrested accused persons admitted that they had been procuring the brown sugar clandestinely from Islampur area for the purpose of selling the same in high rate to their designed customers Shibmandir under Matigara PS, and Siliguri area for their wrongful gain during pandemic COVID time by illegal means.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely i) Humayan Kabir 25 yrs (D/B 1991) s/o Md Amiruddin vill: Tarijote PO, New Rangia PS, Matigara Dist- Darjeeling ii) Sunney Rai 35 yrs (D/B 1986) s/o Kumar Rai of Gangtok Municipal Corporation Lower Sichey Lingding near Lingding Govt, Jr H.S Lower Sichey PS, Sardar Dist, East Sikim iii) Smt Heena Rai 28yrs W/O Sunney Rai of Gangtok Municipal Corporation Lower Sichey Lingding near Lingding Govt, Jr H.S Lower Sichey PS, Sardar Dist, East Sikim A/P Shibmandir near NBU gate under Matigara PS and arrange for its investigation.


