

In producing herewith Five (05) arrested accused person namely (1) Deepak Kumar (31) S/O Lt. Om Prakash Paswan of Ferbishganj, Ward No-14, PO+PS- Ferbishganj, District-Araria, Bihar, (2) Akilesh Kumar Mandal (34) S/O Lt. Narayan Mandal of Parwa, PO- Parwa, Ward No 09, PS- Ferbishganj, Araria, Bihar (3) Mintu Kumar (31) S/O Sri Tej Narayan Mahato of Shera Nagar, PO+ PS-Ferbishganj, Dist- Araria, Bihar (4) Bijay Kumar Singh (31) S/O Sri Dayanand Singh of Ferbishganj, Ward No-25, PO+ PS- Ferbishganj, Dist- Araria, Bihar and (5) Md Mustafa (25) S/O Lt. Md Hadis of Shanti Nagar, PO- Bokribari Hut, PS- Haldibari, Dist- Coochbehar (Manager of Omkar Lodge) arrested u/s 41 Cr.P.C along with four 04 recovered victim girls namely (1) Madhumita Ghosh (24) D/O Nimai Ch Ghosh of 7/H/5 Roy Charan Paul Lane, PS- Topsia, Kolkata-46, (2) Smt Paromita Baishnab (32) W/O Lt. Jagadish Baishnab of 3 No Sri Nagar Shiv Tala, Madhyamgram, PS- Barasat, Dist- North 24 Pargana (3) Smt Rama Das (32) W/O Sri Tapan Das of Narayan Pur, Kadi Hati, Sir Ramesh Mitra Road, North Dum Dum, PS- Narayan Pur, Dist- North 24 Pargana and (4) Smt Sampa Ghosh (29) W/O Bapi Ghosh of 75 Forward Colony, PS- Bara Nagar, Noapara, Dist- North 24 Pargana along with following seized articles.

I Sudip Kumar Dutta, Sub-Inspector of Police attached to Panitanki TOP, Siliguri PS/SPC as Officer- in-Charge do hereby lodge this complaint against the following accused persons namely (1) Deepak Kumar Suman (31) S/O Lt. Om Prakash Paswan of Ferbishganj, Ward No-14, PO+PS- Ferbishganj, District-Araria, Bihar, (2) Akilesh Kumar Mandal (34) S/O Lt. Narayan Mandal of Parwa, PO- Parwa, Ward No 09, PS- Ferbishganj, Araria, Bihar (3) Mintu Kumar (31) S/O Sri Tej Narayan Mahato of Shera Nagar, PO+ PS- Ferbishganj, Dist- Araria (Bihar) and (4) Bijay Kumar Singh (31) S/O Sri Dayanand Singh of Ferbishganj, Ward No-25, PO+ PS- Ferbishganj, Dist- Araria, Bihar and (5) Md Mustafa (25) S/O Lt. Md Hadis of Shanti Nagar, PO- Bokribari Hut, PS- Haldibari, Dist- Cooch Behar (Manager of Omkar Lodge) to the effect that on 30.07.21 at 23.25 hrs I received a specific input regarding a prostitution racket by the owner and Manager of Omkar Lodge with the girls from outside places of Siliguri at the Lodge styled as "Omkar Lodge" for their wrongful gain using the said lodge as brothel. The matter was diarized vide Panitanki TOP GDE No 691 Dated 29.07.21. Accordingly myself along with SI Ashim Das, SI Arindam Chatterjee, SI Rana Brahma, LASI Sraboni Saha, LHG 471 Bharati Biswas, LCV-593 Shipra Baroi, ASI Biswajit Ghosh, ASI Ratan Kr Ghosh, C/153 Santosh Mahato, C/576 Binay Ch Roy left for Omkar Lodge situated at Hill cart Road, Near Sevoke More, PS- Siliguri, Dist- Darjeeling to verify the veracity of the information by Govt Vehicle. This refers to PNT TOP GDE No 692 dated 29/07/21. There is strong reason to believe that a search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of offender. On the

On the way to Hill cart Road I asked for the presence of I.C Siliguri PS at the spot as a gazetted officer which he agreed and then I called two independent witnesses namely (1) Narayan Thapa S/O Lt Dil Bahadur Thapa of Shalbari, PS Prodhan Nagar, Darjeeling (2) Sajjan Rai S/O Lt Om Bahadur Rai of Gurung Busty, PS- Prodhan Nagar, Dist- Darjeeling. At about 23:45 hrs we reached at Omkar Lodge situated at Hill cart Road, (Near Sevoke More) and cordoned the Lodge. As IC Siliguri PS reached at the spot we then entered the Lodge and there was a search made inside the Lodge Room which had many rooms. One of the rooms was closed. After several knocks one male person opened the door and also found that two female persons and two male persons inside the room. During interrogation they disclosed their identity as Deepak Kumar (31) S/O Lt. Om Prakash Paswan of Ferbishganj, Ward No-14, PO+PS- Ferbishganj, District-Araria, Biha, and Akilesh Kumar Mandal (34) S/O Lt. Narayan Mandal of Parwa, PO- Parwa, Ward No 09, PS- Ferbishganj, Araria, Bihar and two female persons namely Madhumita Ghosh (24) D/O Nimai Chandra Ghosh of 7/H/5 Roy Charan Paul Lane, PS- Topsia, Kolkata-46, Smt Rama Das (32) W/O Sri Tapan Das of Narayan Pur, Kadi Hati, Sir Ramesh Mitra Road, North Dum Dum, PS- Narayan Pur, Dist- North 24 Pargana and they made some contradictory statement about their relationship. On further search recovered 01 pkt unused condom styled as SKORE and one used Dotted Condoms also one bottle of Beer and two glasses. On search of the other rooms found two male persons namely Mintu Kumar (31) S/O Sri Tej Narayan Mahato of Shera Nagar, PO+ PS-Ferbishganj, Dist- Araria, Bihar and Bijay Kumar Singh (31) S/O Sri Dayanand Singh of Ferbishganj, Ward No-25, PO+ PS- Ferbishganj, Dist- Araria, Bihar and two female persons namely Smt Paromita Baishnab (32) W/O Lt. Jagadish Baishnab of 3 No Sri Nagar Shiv Tala, Madhyamgram, PS- Barasat, Dist- North 24 Pargana and Smt Sampa Ghosh (29) W/O Bapi Ghosh of 75 Forward Colony, PS- Bara Nagar, Noapara, Dist- North 24 Pargana. On further search recovered 01 pkt unused condom styled as Kamsutra and one used Dotted Condoms which was lying on floor also one bottle Beer and two glasses. During interrogation they broke down and admitted that they are involved in the illegal business of prostitution for their wrongful individual gain. They further admitted that Md Mustafa S/O Lt. Md Hadis of Shanti Nagar, PO- Bokribari Hut, PS- Haldibari, Dist- Cooch Behar (Manager of Omkar Lodge) and the Owner of said Omkar Lodge using the Lodge as brothel and they invites prostitutes from different areas and allow them to run prostitution using their Lodge as brothel for their wrongful gain. I accordingly seized all the items noted above under proper memo of seizure duly signed by the witnesses. I then arrested them from the Omkar Lodge issuing memo of arrest duly signed and acknowledged by each, it is to be mentioned here that victim girls were separately searched and recovery memo was prepared by me in presence of LASI Sraboni Saha, LHG 471 Bharati Biswas, and LCV-593 Shipra Baroi considering strict decency to their persons and seized all the indiscriminating articles as noted above under proper seizure list in presence of witnesses. The seizure was made between 00:25 hrs to 01:20 hrs.

Under the above circumstances, it is prayed that a specific case may kindly be started against (1) Deepak Kumar (31) S/O Lt. Om Prakash Paswan of Ferbishganj, Ward No-14, PO+PS- Ferbishganj, District-Araria, Bihar, (2) Akilesh Kumar Mandal (34) S/O Lt. Narayan Mandal of Parwa, PO- Parwa, Ward No 09, PS- Ferbishganj, Araria, Bihar (3) Mintu Kumar (31) S/O Sri Tej Narayan Mahato of Shera Nagar, PO+ PS- Ferbishganj, Dist- Araria, Bihar (4) Bijay Kumar Singh (31) S/O Sri Dayanand Singh of Ferbishganj, Ward No-25, PO+ PS- Ferbishganj, Dist- Araria, Bihar and (5) Md Mustafa (25) S/O Lt. Md Hadis of Shanti Nagar, PO- Bokribari Hut, PS- Haldibari, Dist- Coochbehar (Manager of Omkar Lodge) as well as the owner of Omkar Lodge and arrange for its investigation.
