In producing herewith one arrested accused person namely Ramji Singh(M-50) S/O-Lt Jugal Singh of- Pakar Sama, PO- Bishan Pur, PS- Madhuba Pur, Dist- Madhubani(Bihar) A/P Nitai Biri Factory of Amtala Chayanpara, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles (i)20 (Twenty) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 300 ml each when packed, MRP Rs. 50/- each (ii) 20 (Twenty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (iii)01 (One) Nylon Bag which used for carrying the seized articles SL N-) 01 & 02

I, ASI Gopesh Ch. Barman of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 30/07/2021 at 08:15 hrs during special raid duty I received secret source information that, one person is carrying huge quantity of country spirit through Sevoke Road, near Post Office. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with, ASI Mantu Dey, C/1036 Gopal Srivastab, CV/1009 Manoj Thakur left for PO to work out the information. On arrival at Sevoke Road near Post Office at 08:25 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 20 (Twenty) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 300 ml each when packed, MRP Rs. 50/- each (ii) 20 (Twenty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (iii)01 (One) Nylon Bag.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Amtala Chayanpara and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 20 (Twenty) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 300 ml each when packed, MRP Rs. 50/- each (ii) 20 (Twenty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (iii)01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 08:45 hrs to 09:15 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 2000/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Ramji Singh (M-50) S/O-Lt Jugal Singh of- Pakar Sama, PO- Bishan Pur, PS- Madhuba Pur, Dist- Madhubani(Bihar) A/P Nitai Biri Factory of Amtala Chayanpara, PS- Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section, of Law and to arrange for its investigation.
