I, Ananya Sanyal, (wife of Dr. Subrata Sanyal), am a resident of Shubankpally, Siliguri and have lived here for 22 years. My age is 49 years. I would like to inform about the situation that took place today. One night, as I was returning to my home at about 10 o'clock at night, some street dogs ran after the some boys in a scooter. They threw a stone at the dogs ~~but at the~~ directing the stone towards me and threatened me. They threatened that if the dogs attacked again, they will do something to me not keeping in ~~my~~ mind that I am a middle aged female. Today, ^(30th July, 2021) in the afternoon, ^{at about 3:00 pm.} the same boy who threatened me earlier threatened me again to keep the dogs in control alleging repeatedly that they are my dogs. This time he also punched me in my hand (therefore, bruising my hand) and fractured my finger. He also tried to snatch my ornaments. I am a patient of hypertension and all the happenings made me unwell. I have noted the vehicle number of the boy which is WB-74-AR-8803. The boy's name might be Neel Sarkar (as he was uttering it).
