Bijan Roy of Lower Bhanu Nagar, Ward No. 43, PS- Bhaktinagar, Dist- Jalpaiguri (4) Subhash Sarkar (46) S/O Sunil Sarkar of Rathkhola Bazar, Ward No. 22, PS- Siliguri, Dist- Darjeeling (5) Sk Md. I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC, do hereby lodge a written complaint against the above noted accused persons to the effect that on 30.07.2021 at about 18:15 hrs while performing special raid duty at Sevoke Road in front of FBB Big Bazar and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Soumen Midya (19) S/O Anukul Midya (2) Santosh Sharma (32) S/O Ram Bajhan Sharma (3) Mani Roy (20) S/O Lt. Bijan Roy (4) Subhash Sarkar (46) S/O Sunil Sarkar (5) Sk Md. Izazur Rahaman (26) S/O Atihar Rahaman (6) Ajay Mahato (20) S/O Lalbabu Mahato (7) Kishan Mahato (21) S/O Lt. Hitlal Mahato.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and night curfew period. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and night curfew period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Soumen Midya (19) S/O Anukul Midya (2) Santosh Sharma (32) S/O Ram Bajhan Sharma (3) Mani Roy (20) S/O Lt. Bijan Roy (4) Subhash Sarkar (46) S/O Sunil Sarkar (5) Sk Md. Izazur Rahaman (26) S/O Atihar Rahaman (6) Ajay Mahato (20) S/O Lalbabu Mahato (7) Kishan Mahato (21) S/O Lt. Hitlal Mahato and arrange for its investigation.
