Sub: - Complain against an unknown person riding a motorcycle bearing no. WB 74R 3735 of Traffic Violation and taking Wheel Clamp (Government property).

Sir,

On 30.07.2021 in between 14:15 hrs to 14:45 hrs a person riding a Hero Honda CBZ Bike bearing no. WB 74R 3735 was detained by me near "Kuber Furnishings" shop at Sevoke Road - around 50(fifty meters) ahead of the main entry point of 172 Bidhan Road from Sevoke Road towards Sevoke More while I was on Traffic Duty as Motor Cycle Mobile at Sevoke Road as the Bike Rider was riding his bike in the wrong side without Helmet. On detaining him he was asked to produce the documents of his bike and his driving license for taking appropriate action under MV Act-1988 but the person failed to produce any document of his vehicle and valid license and he requested some time to produce the same. Thereafter his vehicle was wheel clamped and he was asked to produce the relevant documents of his bike shortly and I moved at Panitanki More for my duty. Thereafter I returned back after 30 minutes at the spot and did not find the said bike and wheel clamp. On being asked some of the people of the locality stated that the bike owner somehow removed the wheel clamp and took away his bike along with the wheel clamp.

Necessary action under appropriate section of law may kindly be taken in this regard.
