In producing herewith the five arrested accused persons namely (i) Surajit Bera (25), S/O- Ajit Bera of Tekhari, P.O- Tarkeshwar, P.S- Tarkeshwar, Dist- Hoogly, (ii) Sabuj Mandal(21), S/O- Binoy Krishna Mandal of Ward No-1, Roypur Natus Para, Gabbar Danga, North 24 Pargana, (iii) Ashikul Iqbal(19), S/O- Sadiqul Islam of Jaxtala, Kumar Ganj Malda, (iv) Sanjib Hemanta Debnath of Monalisa Apartment, Himachal Bihar, P.S- Matigara, Dist- Darjeeling, (v) Papai Sarkar (22), S/O- Nipen Sarkar of Gangamali Ambedkar, P.S- Bhaktinagar, Dist- Jalpaiguri arrested u/s 41 Cr.P.C.

1. SI Sushanta Dhar of Matigara PS SPC lodged a written complaint to the effect that on 30.07.2021, while performing SPL Mobile duty under Matigara PS area found five persons namely (i) Surajit Bera (25), S/O- Ajit Bera of Tekhari, P.O- Tarkeshwar, P.S- Tarkeshwar, Dist- Hoogly, (ii) Sabuj Mandal(21), S/O- Binoy Krishna Mandal of Ward No-1, Roypur Natus Para, Gabbar Danga, North 24 Pargana, (iii) Ashikul Iqbal(19), S/O- Sadiqul Islam of Jaxtala, Kumar Ganj Malda, (iv) Sanjib Debnath (24), S/O- Hemanta Debnath of Monalisa Apartment, Himachal Bihar, P.S- Matigara, Dist- Darjeeling, (v) Papai Sarkar (22), S/O- Nipen Sarkar of Gangamali Ambedkar, P.S- Bhaktinagar, Dist- Jalpaiguri were loitering at City Centre, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No-403/2020-DM-1 (A) Dated- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons (i) Surajit Bera (25), S/O- Ajit Bera of Tekhari, P.O- Tarkeshwar, P.S- Tarkeshwar, Dist- Hoogly, (ii) Sabuj Mandal(21), S/O- Binoy Krishna Mandal of Ward No-1, Roypur Natus Para, Gabbar Danga, North 24 Pargana, (iii) Ashikul Iqbal(19), S/O- Sadiqul Islam of Jaxtala, Kumar Ganj Malda, (iv) Sanjib Debnath (24), S/O- Hemanta Debnath of Monalisa Apartment, Himachal Bihar, P.S- Matigara, Dist- Darjeeling, (v) Papai Sarkar (22), S/O- Nipen Sarkar of Gangamali Ambedkar, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
