The writing was in my name. I have strong belief that the persons involved in the shameful act knows me very well and has painted the obscene pictures & writings only to malign my image and prestige in the society. My name Sabita Prasad Jaiswal is only known in my family and nobody in the society knows my name. I have no other option left so I came before you. The camera footing shows two persons are writing in the wall.

It is requested before you in folded hand to kindly take strict necessary action against the persons involved in the said incident so that this type of incident never occurs again.
