Vihar, Matigara, am registering a General Diary entry at
Matigara P.S regarding Ms. Temimah Marean, one of the
visitors at the church where I work i.e. City Church
G-321, City Centre, Matigara.

Today, at around 6 pm. after our usual
church service, Temimah Marean, who was present
at that time, used aggressive force against me by
punching me on the left side of my face.

On 14th of July, 2021, Temimah Marean,
residing in M.I.G, Uttorayan
trespassed into my residential property forcefully
when the gate was locked by jumping over it. We have
video of the same. Temimah Marean has also been spreading
rumours about me and my husband and we have
proof of the text messages sent to us by her.
