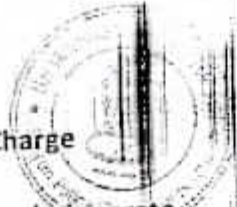

Sir,

In producing herewith one accused person namely Dipankar Saha(22) S/O Lt Dillip Saha, of Vidya Chakra Colony Netai Paul Sarani, near Ashighat Road, w/n- 44, PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 01 (One) Bottle of Imperial Blue Classic Grain Whisky (Containing 375 ML.)
2. 01 (One) Bottle of Sterling Reserve Classic Blended Whisky B7(containing 180 ML).
3. 01(One) Bottle of Mc Dowell's No-1 Superior Whisky Original (containing 375 ML).
4. 02(Two) Bottle of Mc Dowell's No-1 Superior Whisky Original (each bottle containing 180 ML).
5. 02(Two) Bottle of Old Monk XXX Premium RUM (each bottle containing 180 ML).
6. 03(Three) Bottle of Himalayan Gold 60UP PET Country Spirit (each bottle containing 600 ML).
7. 02(Two) Bottle of Himalayan Gold 60UP PET Country Spirit (each bottle containing 300 ML).
8. 01(One) Bottle of BOSS 60UP PET Country Spirit (each bottle containing 600 ML).
9. 05(Five) Bottle of BOSS 60UP PET Country Spirit (each bottle containing 300 ML).

I, ASI Biswajit Saha of Bhaktinagar PS lodged a written complainant against the above noted person to the effect that today i.e. on 01.08.2021 at 19.05 hrs received a source information that one person namely Dipankar Saha has gathered huge amount of liquor illegally in his house for selling the same in the market for his wrongful gain. Accordingly diarized the fact in GD vide Bhaktinagar PS GDE No- 34 Dated 01.08.2021 and shared the information with I/C Bhaktinagar PS and as per his kind instruction this refers to Bhaktinagar P.S. GDE No- 35 Dated 01.08.2021 at 19.10 hrs I along with ASI Rabin Lama, CVF 614 Sumit Kumar Roy and CVF/ 619 Dharmendra Roy left for Vidya Chakra Colony Netai Paul Sarani in the house of Dipankar Saha and identified by the source our police party cordoned the house of Dipankar Saha and conducted raid and recovered the above noted articles from his house from the exclusive possession of the above noted accused person namely Dipankar Saha. On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same to his design customers as well as in open market at Vidya Chakra Colony area for his wrongful gain. In presence of witnesses Namely Shiv Roy(23), s/o Dipak Roy of Dasarath Pally, Kalibari Road, w/n-44, PS- Bhaktinagar Dist- Jalpaiguri I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person. The seizure was made between 19.45 hrs to 20.25 hrs as he violated the rules and norms of Bengal Excise Act as such. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Dipankar Sha(22) S/O Lt Dillip Saha, of Vidya Chakra Colony Netai Paul Sarani, near Ashighat Road, w/n- 44, PS- Bhaktinagar Dist- Jalpaiguri under proper section of law and arrange for its investigation.
