Subject: FIR

In producing herewith (i) One vehicle bearing No- WB 76- 8917 loaded with river bed materials and (ii) One vehicle bearing No- WB 78- 1161 loaded with river bed materials under seizure, I, SI Kalipada Barman of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver and owner of the above noted vehicles bearing No- WB 76- 8917 and WB 78- 1161 to the effect that today on 03.08.2021 at 00.45 hrs in course performing mobile van duty along with my accompanied force (C/809 Mingnam Thergole Sherpa and CV/941 Pushkar Tamang both of Matigara PS, SPC) vide MTG PS GDE No- 98 dated -02.08.20 found the above noted vehicle bearing no. WB 76- 8917 and WB 78- 1161 were coming from Tumbajote side towards Matigara side. I tried to detain the above noted vehicles at Beldangi, Tumbajote but driver of both the vehicle fled away from the spot keeping their respective vehicle on road. Subsequently, I checked both the vehicles bearing no- WB 76- 8917 and WB 78- 1161 and found both are loaded with river bed materials but no valid documents/royalty in support of the river bed materials.

From the above fact, it is found evident that drivers and owners of the above noted vehicles bearing No- WB 76- 8917 and WB 78- 1161 are involved in carrying of river bed materials by illegal means for their wrongful gain. Accordingly, I seized the above noted vehicles bearing No- WB 76- 8917 and WB 78- 1161 both loaded with river bed materials.

Hence, I pray that a specific case may kindly be started against the drivers and owners of the above noted vehicles bearing No- WB 76- 8917 and WB 78- 1161 under proper section of Law and arrange for its investigation.
