Sir,

I am producing herewith the following seized articles viz 1) One black coloured Monitor of "Compaq" with adapter, 2) One black coloured CPU of "HP", 3) One black coloured Key Board of "Zebronics" with mouse, 4) One black coloured Scanner, 5) One white coloured Printer loaded with paper roll, 6) One Dongle (USB Stick) of Reliance 3 G, 7) 06 (six) unused Paper Roll and 8) Cash Rs. 220/- and submitting a written complaint against one Dwijen Das S/O Unknown of Shaktigarh near Sailendra Smriti Pathagar o Club, Ward No. 31, PS- New Jalpaiguri, Dist- Jalpaiguri to the effect that on 03.08.2021 at 16.05 hrs received an information that an online gambling is going on inside the room cum shop situated at Jalpaimore, in front of Steel Factory under Siliguri PS, SPC. Accordingly I informed the matter to ACP, D.D, SMP and as per his kind direction I diarized the matter vide D.D, SMP GDE No. 15 dt- 03.08.2021 and myself along with Const. 371 Sushanta Dey, Const- 932 Pabitra Das and CV-230 Jayanta Singha all of D.D, SMP left for the spot to verify the veracity of information.

At 16.20 hrs on reaching the spot found that one person is selling online coupon (Ticket) through computer for prize through internet connection to some customers for his wrongful gain. Seeing the police party the customers as well as the owner of the said lottery shop fled away from the said shop. On local enquiry it is learnt that one Dwijen Das S/O Unknown of Shaktigarh near Sailendra Smriti Pathagar o Club, Ward No. 31, PS- New Jalpaiguri, Dist- Jalpaiguri is run the said online lottery shop illegally using internet access. On being searched the spot the above noted Gambling articles were found lying there. Accordingly I seized all the above noted articles in presence of local witnesses under proper seizure list. The seizure was made in between 16.25 hrs and 17.05 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Dwijen Das S/O Unknown of Shaktigarh near Sailendra Smriti Pathagar o Club, Ward No. 31, PS- New Jalpaiguri, Dist- Jalpaiguri.
