I, SI Subir Chowdhury of Matigara PS SPC lodged a written complaint to the effect that on 04.08.2021 while performing SPL Mobile duty under Matigara PS area found Two persons (i) Md. Taijul (25), S/O Lt. Mansur Ali of Railgate, Matigara, Biswas Colony, PS - MTG, Dist - DJG, (ii) Nityananda Barman (25), S/O Lt.
