

I, SI Subir Chowdhury of Matigara PS SPC lodged a written complaint to the effect that on 04.08.2021 while performing SPL Mobile duty under Matigara PS area found Two persons (i) Md. Taijul (25), S/O Lt. Mansur Ali of Railgate, Matigara, Biswas Colony, PS – MTG, Dist – DJG, (ii) Nityananda Barman (25), S/O Lt. Haren Barman of Himul, Tarabari jote, PS – MTG, Dist - DJG were loitering at City Centre, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021 Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Mansur Ali of Railgate, Matigara, Biswas Colony, PS – MTG, Dist – DJG, (ii) Nityananda Barman (25), S/O Lt. Haren Barman of Himul, Tarabari jote, PS – MTG, Dist - DJG under proper section of law and arrange for its investigation.
