In producing herewith 04 (four) arrested accused persons namely (i) Md Chatu @ Md. Raju (23) S/O Lt. Tafijul of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri (ii) Sanju Das (39) S/O Lt. Ananda Das of Dashrath Pally, W/No. 44, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri (iii) Md. Guddu @ Md. Samir Hossain (19) S/O Lt. Md. Jashim of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri (iv) Imteaj @ Md. Babu (31) S/O Md. Ajad of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri arrested u/s 41 Cr.P.C along with the following articles viz:

- (i) One metal made knife with wooden butt from the possession of Md Chatu @ Md. Raju which was kept in his right hand.
- (ii) One metal made knife with wooden handle from the possession of Sanju Das which was kept concealed on his back side.
- (iii) One square hallow pipe made of iron from the possession of Md. Guddu @ Md. Samir Hossain and
- (iv) One nylon rope length approx 2.5 metres from the possession of Md. Imteaj @ Md. Babu.

I, ASI Biplab Kumar Das of Bhaktinagar PS, SPC do hereby lodge a written complaint against the above noted accused persons and others to the effect that on 03.08.2021 at 01.45 hrs vide GDE No. 103 Dated 03.08.2021 received a source information that 11/12 youth had assembled at Isckon Mandir Road near gate No. 2, with a view to commit dacoity in a house at that area. Subsequently, after sharing the information with my superiors and as per their direction, at 01.55 hrs myself along with ASI Rabin Lama, ASI Biswajit Saha and force of Bhaktinagar P.S left for the place to work out the information vide Bhaktinagar P.S GDE No- 104 Dated-03.08.2021. We reached at near Isckon Mandir Road at 02.25 hrs and subsequently cordoned off the suspected persons as shown by the source with strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Anchan More near Isckon Mandir Road. Seeing police personnel they tried to flee away but on hot chase we managed to apprehend above noted 04 (four) arrested accused persons along with seized articles as mentioned above. However, the other persons manage to flee away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at that area.

I therefore, seized the above noted articles under proper seizure list duly signed by the witnesses acknowledged by the accused persons. The whole procedure was made in between 02.45 hrs to 03.20 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized articles at Bhaktinagar P.S for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Anchan More, Isckon Mandir Road. It is also revealed from them that some others have been assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted arrested accused persons viz: (i) Md Chatu @ Md. Raju (23) S/O Lt. Md. Tafijul of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri (ii) Sanju Das (39) S/O Lt. Ananda Das of Dashrath Pally, W/No. 44, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri (iii) Md. Guddu @ Md. Samir Hossain (19) S/O Lt. Md. Jashim of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri (iv) Md. Imteaj @ Md. Babu (31) S/O Md. Ajad of Ashraf Nagar, W/No. 42, P.O. Haidarpara, P.S. Bhaktinagar, Dist. Jalpaiguri and others and arrange for its investigation.
