I, Abdul Salam Ansari S/o Md Siddiqui Ansari r/o Kamrangaguri, post office New satellite township police station NJP District Jalpaiguri, beg to report you the following facts:-

1. That yesterday i.e on 27.07.2021 at about 10.30 pm (night) my son of my in law namely Nehal Ahmad Raza S/o Md Khurshid Alam went for throwing garbage outside our house at that time our one nooralam @ bittu S/o Md Raju started abusing him and address him by saying that "Bihari Ka bacha" where are you going , come here I will show you" And when he restrain him from abusing him at that time he started to assault him brutally by fists and blows and by iron knuckle warn by him in his fingers. Finding no other alternative he raised hue and cry for help and hearing his cry I, my son and other my family members and some neighbour in my area went to save him and at that time said Noor Alam @bittu started to abuse us also then we not to boil the situation silently went to our house taking said Nehal Ahmed Raza.

Along with 10 /15 person all of same area arm with deadly weapon like sword iron rod, battam, hockey stick came in front of my house and started to abuse in filthy language in told to open our door but out of fair we lock door from Inside and requested to go away but they become furious and started shouting in loud voice to open the door otherwise they would burn down our house and with intention to break the door started pushing the door heavily and one of them put sword inside the door as the result of which my son namely Afroz Ansari got injury in his left leg and blood oozing out from his leg and when could not break the door at that time and some of them entered into the house by climbing the wall and open the lock and then all of them entered into the house and started assault me., my son, Nehal Ahmed Raza and told that we will finish all " Bihari ka bacha and throw all bihari's
