Sir,

With due respect, I am producing herewith the arrested accused person namely Ajoy Dey (21 yrs) S/O Subhash Dey of Surya Sen Colony, Block-B, PS- NJP, Dist- Jalpaiguri under arrest and 01 improvised small Fire arm (One shooter) measuring 16 cm in length including its 9 CM barrel with one trigger, striking hammer, striking pin and in working condition loaded with 01 (one) round live ammunition seized from the possession of the said accused. The ground of arrest duly been communicated with him.

I SI Samik Paul of NJP PS, SPC do hereby lodge this written complaint against the arrested accused Person namely Ajoy Dey (21 yrs) S/O Subhash Dey of Surya Sen Colony, Block-B, PS- NJP, Dist- Jalpaiguri. In this regard I beg to report that today i.e. on 30.07.21 at 17.35 hrs I received a secret information that one person has been seen moving suspiciously at near NJP Rly Station, in front of Reservation counter under NJP PS and most probably for committing heinous crime and he possess one small Fire arm with ammunition. Diarised the information vide NJP PS GDE No 1599 dated 30.07.2021 and informed the fact to you. As per kind order and direction myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left NJP Rly Station opposite Reservation counter to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Reservation counter under NJP PS at 17.55 hrs and as indicated by source we able to apprehend one person. We searched him immediately and found 01 small Fire arm (One shooter) measuring 16 cm in length including its 9 cm barrel with one trigger, striking hammer, striking pin and one magazine in working condition loaded with 01 round live ammunition in his possession which he was carrying in his waist concealed underneath the shirt. On interrogation he disclosed his name and address as noted above. He admitted that earlier he was involved in several crimes under NJP PS. He exclusively possessed this improvised fire arm loaded with 01 (one) live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm which is found in his possession.

Thus when his involvement in carrying and possessing illegal fire arm was established, I seized that improvised fire arms loaded with 01 (one) round of live ammunition under proper seizure list duly signed by him as well as by available witnesses between 18.40 hrs to 19.50 hrs on 30.07.21 and arrested him by preparing memo of arrest informing him the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused person namely Ajoy Dey (21 yrs) S/O Subhash Dey of Surya Sen Colony, Block-B, PS- NJP, Dist- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm loaded with live ammunition with an objective to commit heinous crime in the locality.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Ajoy Dey (21 yrs) S/O Subhash Dey of Surya Sen Colony, Block-B, PS- NJP, Dist- Jalpaiguri under appropriate section of law and arrange for its investigation.
