Sir,

In producing herewith one accused person namely Ananda Barman (33yrs) Male S/o. Jitu Das of Baram, Power Grid, PO. Baram, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10(Ten) bottle of pet galaxy boss 60Up country spirit containing 600 ML each.
2. 01(one) bottle Himalayan Gold Pet. 60 up County spirit Containing 600 ML.
3. 05(five) Bottles king fisher premium beer Containing 650 ML each.
4. 02 (two) open hagen Denmark Toburg premium beer strong each bottle containing 650 ml

I, ASI. Biswajit Ghosh of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that on 30.07.20:1 at 18:15 hrs while myself along with force left for Evening raid Duty Vide Ambari-Falakata OP GDE No. 1052 Dated: 30.07.2021 in course of said duty I received an information from my source that one Ananda Barman (33yrs) Male S/o. Jitu Das of Baram, Power Grid, PO. Baram, PS-NJP, Dist- Jalpaiguri which is huge amount of liquor illegally for selling the same in the customer for his wrongful gain. Accordingly I informed to C/C Ambari Falakata out post about the information. As per his kind instruction I along with, NVP/130 Nandan Roy, and ASI. Sallendra Singh proceed to Baram, Power Grid to work out the information. At 18:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the Shop of one Ananda Barman (33yrs) Male S/o. Jitu Das of Baram, Power Grid, PO. Baram, PS-NJP, Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely one Ananda Barman (33yrs). On demand he could not produce any valid license/documents in support of said liquor. He become a nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/O. Lt. Ashim Majumder of Chakiavita, Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and (2) Subash Sarkar S/O Lt. Narayan Sarkar of 5/10 P. Colony, Ambari-Falakata, PO. Kamarvita, PS-NJP Dist-JPG and I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19.05 hrs to 19:25 hrs. And I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Ananda Barman (33yrs) Male S/o. Jitu Das of Baram, Power Grid, PO. Baram, PS-NJP, Dist- Jalpaiguri under proper section of law.
