Sir,

With due respect, I am producing herewith the arrested accused person namely Prakash Thakur (50 Yrs/M) S/O late Late Maheswar Thakur of South colony Bazar, PS- NJP, Dist. Jalpaiguri under arrest and the following articles under seizure. The ground of arrest has been communicated with him.

1. 20 Empty bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, PSI Ajay Pradhan presently attached with NJP PS under your kind control beg to state that today i.e. on 30.07.21 I along with the force left PS to perform evening mobile van duty vide NJP PS GD Entry No-1585 dated 30.07.2021. During my mobile van duty at 18.05 hrs I received a secret source information that one person namely Prakash Thakur of South Colony Bazar is selling ID liquor illegally at his residence at South Colony Bazar under PS- NJP, Dist- Jalpaiguri for his illegal gain. Accordingly, informed the fact to you and as per your kind direction and instruction myself along with C/949 Bappi Mondal and NVF/0064 Paramal Roy left for South Colony Bazar to work out the information in hand. At about 18.45 hrs we arrived at the residence of accused Prakash Thakur of South Colony Bazar and being shown and identified by the source we held raid at his residence and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 18.55 hrs to 19.35 hrs on 30.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Prakash Thakur (50 Yrs/M) S/O late Late Maheswar Thakur of South colony Bazar, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
