In producing herewith one arrested accused person Moti Roy (29 yrs), s/o-Brajakanta Roy of Simulguri, PO- Kundardighi, PS- NJP, Dist-Jalpaiguri under arrest along with selzed articles viz (I) 14 (fourteen) sealed bottles of 60 up Country sprit containing 600 ml each and styled as "Boss" I ASI Sanjoy Saha of Milanpally OP under NJP PS/SPC do here by lodged a written complaint to the effect that today on 30/7/21 at 20:05 hrs acting on a tip-off source information myself along with ASI Subrata Sen C/- 980-Sadhan Barman, C/-445- Dilip Roy had been to Simulguri under Milanpally OP boarding in a PS govt. Vehicle to work out the Information that a huge number of country sprit are stocked in the house of one Moti Roy (29 yrs), s/o-Brajakanta Roy of Simulguri, PO- Kundardighi, PS- NJP, Dist-Jalpaiguri without license to sale the same in local liquor selling dens. This refers to Milanpally OP GDE No-712, dt-30/07/21. On arrival at Simulguri at the house of Moti Roy, I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Moti Roy and could recover the above noted huge amount of liquor. During raid the above noted accused person vids arrested from whose exclusive possession the above noted liquors were found. The entire articles were kept hidden under wooden table of the house. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person and took into the custody. The seizure and label was made in between 20:40 hrs to 20.50 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Moti Roy (29 yrs), s/o-Brajakanta Roy of Simulguri, PO-Kundardighi, PS-NJP, Dist-Jalpaiguri.
