In accordance herewith the arrested accused person namely Naryan Mandal (38) S/O Lt. Moti Mandal of Natun Busty, PS- NJP, Dist.- Jalpaiguri under arrest with following articles under seizure. The ground of arrest duly been communicated with him.

1. 22 (Twenty Two) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, SI Kamalesh Joarder presently attached with NJP PS under your kind control beg to state that today i.e. on 30.07.21 while myself along with party were performing Night Mobile Patrol duty vide NJP P.S. GD Entry No. 1611, Dated 30/07/21, at about 22:30 hrs I received a secret source information that one person namely Naryan Mandal of Natun Busty, PS- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally from his residence at Natun Busty, under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, informed the fact to you and as per your kind direction and instruction myself along with C/1028 Bijay Pariar and NVF/0065 Prakash Roy left for Natun Bazar, to work out the information. At about 22:50 hrs we arrived at the residence of accused Naryan Mandal of Natun Busty and as identified by the source we held raid in his residence. During raid I found above noted Country Spirit lying in his kitchen room. On interrogation house owner disclosed his identity as noted above and also confessed that he is selling I/D liquor from his residence since long for his wrongful gain, also failed to produce any documents/licence in respect of store/sale of said I/D liquor found at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all legal formalities of arrest. The whole process of search, seizure & arrest was made in between 22:50 hrs to 23:20 hrs on 30.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Naryan Mandal (38) S/O Lt. Moti Mandal of Natun Busty, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
