Dear Sir,

I, Sri Rakesh Kumar Swarnakar, s/o Kapilde Swarnakar, resident of Janata Para, NJP, Bhaktinagar do bring to your kind notice the following incident: Today (30/7/21) when I was with my-in-laws (Address: Janata Para, NJP), my wife (Powati Swarnakar) and my sister-in-law were assaulted brutally by Amardeef Saha, Son of Gobordhan Saha and some of their associates. While the assault was underway, a foul smelling liquid was thrown on my wife and her sister - we suspect it to be some form of acid. My wife is in serious condition and is admitted to Siliguri hospital from where she has been referred to Noot Bengal medical collage. We are under constant threat and is fearing for our lives. The medical documents will be produced before you tomorrow if needed. I therefore, beg you to protect us from the aforesaid nefarious elements by taking necessary measures.
