Sir,

In producing herewith arrested accused person namely ,(1) Suraj Monger(40) S/O Krishna Kumar Monger of Gurung Busty,Ps.Pradhan Nagar,Dist-Darjeeling (2) Dipayan Mallick(33) S/O Lt. Ratan MALlick of 45/6 Baghajatin Colony,Ps.Pradhan Nagar ,Dist-Darjeeling along with seized articles viz:-

- (i)75(seventy five) strips of "winspasm forte" capsules, (each capsules contains Dicylomine Hydrochloride 10 mg, Tramadol Hydrochloride 50 mg, Acetaminophen 325 mg), each strips containing 08 capsules and marked as Exhibit-A, (Total capsules 600)
 - (ii)02 (two) strips of "winspasm forte" capsules, each strips containing 08 capsules taken from mother packets exhibit "A" for examination and marked as exhibit "A-1"
- One plastic carry bag on which Sl.no. i was kept.

I beg to report that today on 01.08.21 at about 20:05 hrs received source information that one person named Suraj Monger (40) S/O Krishna Kumar Monger of Gurung Busty,Ps.Pradhan Nagar,Dist-Darjeeling is supplying illegally procured spurious drugs to young youths at Gurung Busty more and its adjacent area under PS Pradhannagar. Accordingly the matter was diarized in General Dairy vide Pradhannagar PS GDE no- 55 dt. 01.08.21 and informed you, without making any delay myself along with ASI.Ratan Pradhan Pradhan, C/V 646 Babon Chandra Das and C/V 128 Ajay Kr sahani,CV/131 Ranjan Sharma all of Pradhannagar PS rushed to the spot at Gurung Busty More, Pradhannagar.

At about 20:30hrs reached at Gurung Busty More and requested two disinterested person namely Anuradha Lama D/O Lt.Sanjeeb Lama of Gurung Busty More, PS Pradhan Nagar ,Dist-Darjeeling ,(2)Sadhana Subba D/O Birbal Subba of -DO-to stand as a witness to the search and seizure if any.

As pointed by the source we found that two person are standing one of them possessing a plastic carry bag and delivering other one person . We cordoned both of them in presence of the witnesses and apprehended . We disclosed our identity as police personnel. On being asked the person who posses the carry bag disclosed his name as (1) Suraj Monger(40) S/O Krishna Kumar Monger of Gurung Busty,Ps.Pradhan Nagar,Dist-Darjeeling and other one who was receiving disclosed his identity (2) Dipayan Mallick(33) S/O Lt. Ratan MALlick of 45/6 Baghajatin Colony,Ps.Pradhan Nagar ,Dist-Darjeeling. After maintaining all formalities conducted search and noticed the plastic carry bag containing huge quantities strips of capsules .

On being asked in respect of such possession, they stated different statement at different times, which arouse suspicion that they procured the same illegally for its clandestine disposal. Further , they also could not produce any papers in support of such possession of strips of capsules. On further interrogation the apprehended persons stated that they are selling & purchasing illegal drugs at that locality for their wrongful gain.

Accordingly, I prepared seizure list and seized the above noted articles, labeled it duly signed by the witnesses and acknowledge by the accused person and witnesses and arrested both accused persons namely (1) Dipayan Mallick(33) S/O Lt. Ratan MALlick of 45/6 Baghajatin Colony,Ps.Pradhan Nagar ,Dist-Darjeeling ,(2) Suraj Monger(40) S/O Krishna Kumar Monger of Gurung Busty,Ps.Pradhan Nagar,Dist-Darjeeling w/s 41 CrPC. The seizure was made in between 20:55 hrs and 2150 hrs.

Under the above circumstances, I pray before your kind end to start a case against the above said arrested person namely (1) Dipaya Mallick(33) S/O Lt. Ratan Mallick of 45/6 Baghajatin Colony,Ps.Pradhan Nagar ,Dist-Darjeeling ,(2) Suraj Monger(40) S/O Krishna Kumar Monger of Gurung Busty,Ps.Pradhan Nagar,Dist-Darjeeling under proper section of law and caused its investigation.
