In producing herewith one accused person namely Shyam Pradhan (39) S/O Lt. Nakul Pradhan of Jyotinagar, Baikuntha Pally, W/no-41, PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Two (02) Bottle of KINGFISHER Strong Premium Beer (each bottle containing 650 ML).
2. Three (03) Pouch of Officers Choice DELLYE Whisky (each Pouch of containing 180 ML).
3. One (01) Bottle of Officers Choice DELLYE Whisky (each Bottle of containing 180 ML).
4. Five (05) Bottle of Old Monk Mature XXX Premium RUM (each bottle of containing 180 ML).
5. Four(04) Bottle of Mc Dowell's No-1 Mature XXX Premium RUM(each bottle of containing 180 ML)
6. Seven (07) Bottle of Mc Dowell's No 1 LUXURY Premium Whisky (each bottle containing 180 ML).
7. Four (04) Bottle of Mc Dowell's No 1 Superior Whisky Original (each bottle containing 180 ML).
8. One (01) Bottle of Mc Dowell's No 1 Superior Whisky Original (containing 375 ML).
9. Four (04) Bottles of ROYAL STAGE Blended WHISKY (each bottle containing 180 ML).
10. One (01) Bottles of ROYAL STAGE Blended WHISKY (containing 375 ML).
11. Eight (08) Bottles of IMPERIAL BLUE Classic Grain Whisky (each bottle containing 180 ML).
12. Two (02) Bottle of IMPERIAL BLUE Classic Grain Whisky (each bottle containing 375 ML).
13. One (01) Bottle of Starling Reserve Whisky B7 (containing 180 ML).
14. One(01) Magic Moments Pure Grain VODKA(containing 180 ML).
15. Two(02) Himalayan Gold 60UP PET Country Whisky (each bottle containing 600 ML).
16. One (01) Black Colour Polyester Hand Bag, which was carry the above noted seized Articles.)
17. One (01) Red & Blue Colour Pitto Bag (Which was carry the above noted seized Articles.)

I, ASI Biswajit Saha of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 28.07.2021 at 20.10 hrs received a source information that at G.P. More, near Kathgola, Bhanu Nagar, w/n-42, PS-Bhaktinagar, Dist-Jalpaiguri have gathered huge amount of liquor illegally in the open market for selling the same to the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-1730 Dated 28.07.2021. I informed I/C Bhaktinagar about the information. As per his kind instruction I along with, ASI Rabin Lama, ASI Biplob Kumar Das, CVF/614 Dharmendra Roy, CVF/ 614 Sumit Kumar Roy and CVF/14 Labanya Roy proceeded G.P. More, near Kathgola, Bhanu Nagar to work out the information. At 20.25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid in the open market at G.P. More, near Kathgola, Bhanu Nagar and recovered the above noted articles from the possession of above noted accused person namely Shyam Pradhan (39). On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same in the customer since long for his wrongful gain. In presence of witnesses namely Molin Ch. Roy s/o Sri Manoranjan Roy of Dakkhin Palash, Natun Bazar, PO- Champasari, PS - Pradhan Nagar, Dist.-Darjeeling I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 20.45 hrs to 21.30 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may be started against the accused person namely Shyam Pradhan (39) S/O Lt. Nakul Pradhan of Jyotinagar, Baikuntha Pally, W/no-41, PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
