In producing herewith the arrested accused person namely, (1) Santosh Roy (34) S/o Lt. Bhenu Roy of Vidhya Chakra Colony, Sevoke Road, PS Bhaktinagar, Dist: Jalpaiguri. 2] Brij Mohan Mahato (35) S/O Shivji Mahato, of Do. 3] Manoj Mahato (40) S/o Shivji Mahato of do along with following seized articles viz :-

i] 85 (eighty Five) cartoons said to be **Thinner** each cartoon containing 25 bottles of thinner and each bottle containing 250 ML. said to be thinner having label "AASION PAINTS THINNER" for use in paints & primer. (Total 531 Ltrs).

ii] 02 (Two) pieces of big silver made up of approx length 3 ft.

iv) Approx 5000 (five thousand) pieces of different colour stickers written as "TIGER BRAND"

Seized from the join possession of 1] Santosh Roy (34) S/o Lt Bhenu Roy of Vidhya Chakra Colony, Sevoke Road, PS Bhaktinagar, Dist: Jalpaiguri. 2] Brij Mohan Mahato (35) S/O Shivji Mahato, of Do. 3] Manoj Mahato (40) S/o Shivji Mahato of Do, under proper seizure list in presence of local disinterested witnesses.

I, PSI Sabin Yonjan Tamang of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge the written complaint against the accused person namely 1] Santosh Roy (34) S/o Lt Bhenu Roy of Vidhya Chakra Colony, Sevoke Road, PS Bhaktinagar, Dist: Jalpaiguri. 2] Brij Mohan Mahato (35) S/o Shivji Mahato, of Do. 3] Manoj Mahato (40) S/o Shivji Mahato of Do, that on 29.07.2021 while performing K-38 II Van Duty vide GDE No. 1263 dated 28.07.2021 a team of SOG shared information that in the rented house of Santosh Roy, thinner which is being used for using for paint colour was being prepared illegally without any valid paper. I shared the information with I.C. PS and as per his direction, with the team of SOG conducted in the rented house of Santosh Roy at Vidhya Chakra Colony, Sevoke Road, PS Bhaktinagar, Dist: Jalpaiguri at found above noted place seized articles. On interrogation the above noted person stated that they procure Kerosene oil from the dealer, whose shop is opposite Makhan Bhoj. Found the above noted persons had been procuring Kerosene oil fraudulently in connivance with dealer of Kerosene Oil and use the same in preparation of making thinner for using the same as thinner in paints and supply the same in open market for their wrongful gain and cheat the customers at large, after hatching criminal conspiracy. I demanded valid papers for possessing and preparing the same but they could not produce any

documents. Accordingly, I arrested them U/S 41 CrPC and seized the above noted articles under proper seizure U/S 102 CrPC. The seizure was made in between 16.35 hrs. to 17:05 hrs.

Hence, I pray before you that a special case may kindly be initiated against the above noted accused persons and arrange for its investigation.
