In producing herewith the 06 (six) accused persons namely (1) Rajib Sarkar (40 yrs) S/O - Dipu Sarkar of 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (2) Pankaj Barui (40 yrs) S/O- Late Sankar Barui, of 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (3) Amal Kumar Bose (62 yrs) S/O- Lt. Gour Gopal Bose of Park Street, 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (4) Liton Roy (44 yrs) S/O- Sri Niranjan Roy of 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (5) Swapan Chakraborty (66 yrs) S/O- Late Khitish Chakraborty of Guru Saday Dutta Road, North Bharat Nagar, Ward No- 24, PS- Siliguri, Dist- Darjeeling and (6) Bipul Das [35 yrs] S/O- Lt. Santosh Das of Durgadas Colony, Ward No- 20, PS- Siliguri, Dist- Darjeeling along with the following seized articles Viz:-

(a) One Scanner of Zechie, (b) One Monitor of Lenovo, (c) One Key Board, (d) One CPU of VXL, (e) One CPU of HP, (f) One Printer machine of EPSON, (g) One mouse, (h) One Adopter, (i) Two power cable, (j) One VGA cable, (k) One printer cable, (l) One Dongle, 3 G Reliance, (m) One Skin touch Mobile of Oppo, (n) One Skin touch Mobile of Redme, (o) One Skin touch Mobile of MI, (p) one Skin touch Mobile of LYF, (q) One Keypad Mobile of Samsung, (r) Cash Rs. 8,900/- (Eight thousand nine hundred) only in the following denomination:- Rs.500 x 9= 4500/-, (ii) 200 x 5= 1000, (iii) 100 x 17=1700/-, (iv) 50 x 17=850/-, 20x13= 260/- and 10 x 5= 50/-.

PSI Mihir Majumder of Siliguri PS lodged this written complaint against the above noted accused persons to the effect that, today on 04.07.2021 during my R/T mobile van duty, I received my reliable source information that an online gambling (LOTO) is going on at 1 no Dabgram in front of Dabgram Matrisadan, Ward no- 23, under Siliguri PS inside a shop. Accordingly, I informed the matter to I/C Siliguri PS and as per his kind direction myself along with my accompanied force left for the spot to verify the veracity of information. On arrived at 10.50 hrs at the spot found that the above noted accused persons are engaged in online gambling (LOTO) with the help of Computer with a view to wrongful gain and wrongful loss to each other's by cash & online transaction. On seeing the police party they try to flee away from the spot but on hot chased we apprehended the above noted accused persons. Accordingly, in presence of independent witnesses, I searched the above noted accused persons and found the above noted articles from their possession which I seized under proper seizure list as they failed to produce any valid licence for their this type of gambling and arrested the above noted six (06) accused persons u/s- 41 Cr.P.C. The search and seizure was made in between 11.05 hrs to 12.45 hrs.

In this circumstances it is clear that, the above noted accused persons namely (1) Rajib Sarkar (40 yrs) S/O - Dipu Sarkar of 1 no Dabgram near Matrisadan, Ward No 23, PS-

Siliguri, Dist Darjeeling. (2) Pankaj Barui (40 yrs) S/O- Late Sankar Barui, of 1 no Dabgram near Matrisadan, Ward No 23. PS- Siliguri, Dist Darjeeling, (3) Amal Kumar Bose (62 yrs)

S/O- Lt. Gour Gopal Bose of Park Street, 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (4) Liton Roy (44 yrs) S/O- Sri Niranjan Roy of 1 no Dabgram near Matrisadan, Ward No 23, PS- Siliguri, Dist Darjeeling, (5) Swapan Chakraborty (66 yrs) S/O- Late Khitish Chakraborty of Guru Saday Dutta Road, North Bharat Nagar, Ward No- 24, PS- Siliguri, Dist- Darjeeling and (6) Bipul Das [35 yrs] S/O- Lt. Santosh Das of Durgadas Colony, Ward No- 20, PS- Siliguri, Dist- Darjeeling violated the provision of W.B.G & P.C Act. Accordingly I arrested them issuing proper memo of arrest.

Hence I pray before you that a specific case may kindly be started against the above noted accused persons under proper section of Law and arrange for its investigation.
