Sir,

In producing here with the accused person namely Punam Poddar @ Anjali Poddar (40) yrs female, W/O Lt Mukhiya Poddar of Santoshi Nagar Near Machli More ward no 05, PS- Siliguri Dist- Darjeeling, along with seized (i) 05 (five) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 500/- (Rs/- five hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1". And size along with seized (i) 14 (fourteen) bottles of Himalaya Gold 60 up Country spirit containing 300 ML in each bottle mentioning M.R.P of Rs- 50/- in each bottle i.e. total amount of Rs- 700/- (Rs/- seven hundred). in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1"

I beg to report that today i.e. on 16/07/21 while performing special raid against illegal alcohol, at 14:45 hrs I received a source information that one person namely Punam Poddar @ Anjali Poddar (40) yrs female, W/O Lt Mukhiya Poddar of Santoshi Nagar Near Machli More ward no 05, PS- Siliguri Dist- Darjeeling, is selling huge alcohol at Santosi Nagar under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Santoshi nagar, area, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No - 585, Dated: 16.07.21. After reaching Santosi Nagar Machli More at 15:15 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept hidden in a gunny bag in his house at Santosi Nagar Machli More. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 15:00 hrs to 15:15 hrs on 16.07.21

Under the above noted fact and circumstances, I therefore, pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Punam Poddar @ Anjali Poddar (40) yrs female, W/O Lt Mukhiya Poddar of Santoshi Nagar Near Machli More ward no 05, PS- Siliguri Dist- Darjeeling, for the possessing and selling alcohol illegally and arrange for its investigation.
