I, SI Prakash Saha of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged written complaint that on 17.07.2021 at 14.30 hrs while performing K-38 II van duty vide GDE No. 1072 Dated 17.07.2021 & MCC No. 2647/21 Dated 17.07.2021 received an source information that huge number of people had assembled at Muthoot Finance Office, Salugara, Sevoke Road, PS Bhaktinagar, Dist. Jalpaiguri flouting the restrictions imposed by the Govt. Of West Bengal. Accordingly, after sharing the information with I.C. PS, as per his direction myself along with ASI Rabin Lama and force including lady police personnel accompanied I.C. PS for conducting raid. Accordingly, at 14.45 hrs, I along with officers and force accompanying Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC reached at Muthoot Finance-Office: Salugara, Sevoke Road and found the above noted persons had assembled for official work, overcrowded without maintaining social distancing and not wearing mask violating the recent order of Govt. of West Bengal vide order No. -753/III-ISS/2M-22/2020 Dated: 14/07/2021. The above noted persons intentionally refused to comply with the order of West Bengal duly promulgated in view of out - break out of Pandemic COVID-19. Their unlawful and malignant act seemed likely to spread the infection of Covid-19 dangerous to life. I demanded him to produce the documents or order to assemble for such overcrowded gathering not maintaining social distancing and without mask but no one could produce order or documents. Hence, I arrested them u/s 11 Cr.P.C under proper memo of arrest after explaining the charge against them.

Under the above circumstance, I request you that a specific case may kindly be started U/S 188/269/270 IPC R/W Sec 51(b) Disaster Management Act. 2005 against the above noted arrested accused persons and arrange for proper investigation of the case.
