Sir,

With due respect I wants to state you that :-

1. That I got married with the accused No: 1 in the year 2017 according to Hindu customs.
2. Accused No: 1 is my husband, Accused No: 2 is my mother in law, Accused No: 3 and 5 is my sister in law, Accused No: 4 is my brother in law.
3. That after the marriage I used to reside in my matrimonial house with all the accused but with the passage of time my relation with the accused become worsen as the accused started immense torture upon me as all the accused starting demanded huge money more than lakhs of rupees which I and my family cannot effort. Accordingly as my family cannot pay the money so all the accused started torture to me both physically and mentally.
4. That out of the wedlock with Accused No: 1, I gave birth to a girl child namely Ahana Das. As I gave birth to a girl child all the accused started treated me with cruelty and my daughter also. Still I kept quite. In the year 2021 I again gave birth to my second girl child namely Anamika Das who is just a month old. Seeing this 2 girl child now all the accused started torture physically in such a way that there was a position that I was decided to commit suicide.
5. That today on 16/7/2021 at about 9:00 am in the morning when I was feeding my child suddenly the accused No: 1 and 4 came to me in a drunken

position and started hitting me with kicks and blows. They caught my hair and forced me to drag outside home. As I was praying for mercy but they didn't listen my words. Accused No: 4 also tore my clothes and catch, hold my private parts of my body.

6. That when I was shouting the accused No: 2, 3 and 5 came running to me and started hitting me with kicks and blows. Accused No: 2, 3 took a sharp knife and put on my throat and tried to kill me. Accused No: 5 took an iron rod and hit me in my back portion.
7. That all the accused also hit my small 2 daughter without any mercy. They also tried to kill my 2 daughter who are very very small in age.
8. That as I was badly injured and was in the ground the accused No: 1 and 4 caught my throat and told me that you r not of my choice. They also told me that my family haven't paid then any dowry amount which leads this torture and moreover as I gave birth to girl child so this child is not of accused No: 1.
9. That I was unable to speak as they tried to kill me and other accused constantly hitting me with kicks and blows and with iron rod. Seeing this nuance I become unconscious and closed my eyes.
10. That latter the neighbor people came and saved me. They took me to my parent's home. Where I went to Siliguri District Hospital on 16/7/2021 at about 11:30 am and shown to OPD where the doctor wrote medicine name and stated that it's a Police Case.
11. That today by luck with the help of neighbor I got save otherwise the accused would have killed me.
12. That now I came before you seeking for help and request you to help me.

Under the above circumstances I pray before you with folded hands requesting you to start an investigation and also to start a specific case against all the accused and also to arrest the accused for their deeds and acts which I will be very much obliged and thankful to you.
