I, Bikash Kumar Singhal, S/o Ratan Kumar Singhal, Partner of Green Ventures would like to state that one Mr. Jiblal Singh and his associates has been calling up from last 2 months that I should pay him money in huge amount otherwise he would not let me develop the project at Lexicon More, Matiagar by the name Green Meadows & The Pacific and he threaten me that he would harm me physically and my employee, staff and labours at the site.

Today at 10 PM, Mr. Jiblal Singh along with his 7-8 associates broke into my premises and hit the security guard. He broke my office, window, door, chair, model of the project. He also hit the labour with stones and bricks.

He also took away 45600 rupees from the cash drawer from the office and also threatened me that he shall murder me if he is not paid more money.

He also took away one desktop from the office and the tin sheet from the boundary. He also threatens the labours to not start the work until he is paid else they also face the consequences.
