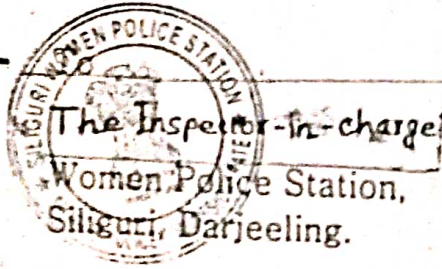

Sir,

I, Smt. Jyoti Basfore, wife of Sri Shekhar Dom, c/o Suresh Basfore presently residing in my parental house at Bhujipani, Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, do hereby begs to state that I had married with Shekhar Dom son of Kisori Dom, resident of Adarsha Nagar, Ward No.4 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling on 26.01.2019 as per Hindu Rites & customs at Bhujipani, Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling.

That after marriage we began to start our marital life on my Matrimonial house at Adarsha Nagar, Ward No.4 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling. That soon after the marriage after 1-2 months later my husband, Shekhar Dom started torturing me both-physically & mentally on simple family matters.

1. That at the time of social marriage, my father gave so many valuable articles like, Gold Chain to my husband, Palank, showcase, Dressing Table, Almeria, & Rs.50,000/- (Rupees Fifty Thousand) in cash etc. and other valuable articles were given by the my relative and my nearest friends which are like "Stridhan Properties" and all that articles were kept by the Shekhar Dom.
2. That the said Shekhar Dom is a habitual drunker and on every night he used to come home at late night and torture upon me for simple reason. He also used to bring his friends at matrimonial house make party upto late night. That my husband, Shekhar Dom is a Drug paddler and related to many more illegal activities. And he is a very infulanceable person of that locality.

4. That when I protest all those illegal and inhuman activities that my husband started physical torture upon me. And I used to bear all such type of inhuman torture made by my husband upon me with a hope that everything will be settled out in future. But the golden time never knocked the door of my life and the torture upon me gradually increased day-by-day by my husband.
5. That thereafter on 15.07.2021 early morning at about 11.30 a.m he started physically torture upon me ,even he tried to catch fire to me by putting kerosene when I protested against my husband, Shekhar Dom for doing such illegal acts, he assaulted me mercilessly and I somehow ran away from my matrimonial house and saved.
6. That my mother-in-law namely Mala Mallik, my brother-in-law namely Raja Mallik and Hina Basfore sister-in-law wife of Bikki Basfore (sister in Law) residing at Tiger Basti they also started physical torture and uses slung languages upon me.
7. That at present I am residing at my parental house and the said Shekhar Dom is continuously threatening me on phone that he shall throw ACID on me in my face. That the said Shekhar Dom is dangerous in nature and character and I am very much afraid that he shall harm me.

Sir, I therefore request you to look into the matter and take necessary legal action against the said Shekhar Dom, Mala Mallik, Raja Mallik and Hina Basfore and punish them according to law for the ends of Justice.
