I would like inform you, that I Partha Debnath, have a computer café at Surya Sen Colony, Block-B, Ward-34, Siliguri faced a harassment issue by person named as Sanjib Barman. There was a meeting held a month ago among the computer Cafes around the Suryasen collage area. The main topic of the meeting is the rate chart discussion, which was concerned to business development in the area. In the aforesaid time all the cafes were to adhere to the rate chart but one of the Café owners named i.e. Sanjib Barman does not agree to the others which has highly affected the student as well as cafes around the collage. Additionally, the aforesaid person also conducts such incident, whereas students and other customers of the area also has harassed.

Then he told her that he would submit her paper freshly for an amount of Rs.100. When I came to know about the incident I naturally got excited and there was a small quarrel between me and him. Then the Police arrived and the quarrel was mutually settled. But even after the mutual settlement the aforesaid person went to the police station and filed a dlary against me.

I will be highly obliged if you could look into the matter and take necessary actions regarding the same. I hope you will take necessary action against the case.
