Roy both of Ambari-Falakata OP, Under NJP PS/SPC had been to Gandar. More, under Ambari Falakata OP. PS. NJP to perform mobile Van duty at 13:35hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Niraj Oraon (22yrs), S/o.
