In producing herewith one accused person namely Arabinda Biswas(27), s/o- Suresh Chndra Biswas of Kherbari Part-3, Bottala Hari Mandir, MGSY Road, Kherbari, Dhubri, Assam(not verified) in custody and the following property under seizure along with seizure list:-

i. One packed and sealed leather packet said to contain "Heroin" having total weight 518 grams
ii. 05 grams of said to be "Heroin" set. "A",

iv. One old used VIVO mobile phone (Golden colour) having IMEI no- 867820048617438. 867820048617420inwhich inserted GIO SIM card having no- 9579102430 marked as exhibit-

v. One Blue and ash colour Rucksack bag styled as :Arctic, Mountain" in which the exhibit -"A" was kept, marked as exhibit -"C"

I, ASI Binod Jha of Special Operation Group, SPC do hereby lodged this complaint to the effect that on 03.08.2021 at 11.45 hrs I received a secret source information that one person carry huge quantity of "Heroin" in his possession, and he is heading towards Siliguri via Ambari Falakata road for selling to the same to his designated customer at a high price. Accordingly I informed the matter to Sri Rajen Chettri, Asst. Commissioner of Police, Detective Department, SPC in writing for his kind information and providing police assistance, vide Detective Department, SPC GDE No. 11 Dtd, 03,08,2021. As per kind order of Sri Rajen Chettri, Asst. Commissioner of Police, Detective Department, SPC myself along with ASI Abu Taleb. ASI Praloy Bhattecharjee. Const- 371 Sushanta Dey all of D.D. SPC and C/126 Satrughna Sen, C-166 Gopla Saha, CV- 233 Amit Mallick, CV-145 Vijay Das of SOG, SPC left for Cannel More under Ambari OP, PS- NJP by govt. vehicle WB-61-A-0137 driven by CD-598 Shibu Das vide Detective Department, SPC vide C.C No- 232 Dt. 03.08.21 to verify the veracity of information corresponding Detective Department, SPC GDE No. 12 Dtd. 03.08.2021. At the time of departure from Detective Department, SPC I took along a digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. On reaching at Cannel More, Baniapara, at about 1235 hrs, 1 called two disinterested witnesses from the spot who were present & available there at that time namely (i) Subash Sarkar, s/o- Lt. Narayan Sarkar of Mahamaya Colony, PO- Kamarvita, Ambari, PS- NJP, Dist- Jalpaiguri and (ii) Hareswar Barman, s/o- Besto Barman of Kalabram, PO- Bhangamore, PS- Mathabhanga, Dist- Coochbihar, a/p- employee of Accence Insulation Pvt. Ltd, Baniapara Cannel more, PS- NJP, Jalpaiguri and disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness.

At about 12.50, on being identified by the source, we found one young boy was sitting inside the bus stop at Cannel more, Baniapara, carrying a Blue and ash colour rucksack on his left arm. The suspect seemed to be waiting there for some one.

We detained the above noted boy along with his bag which was kept in his left arm. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further
