Sir,

In producing herewith one arrested accused person namely (i) Md Makbul(36) s/o-Md Khalil of Jyotirmoy Colony near Rail gate PS-NJP Dist-Jalpaiguri, along with the following articles under seizure:

- (i) One black colour Monitor (Dell)
- (ii) One black colour Monitor (ACER)
- (iii) Two numbers of CPU
- (iv) Two numbers of printers
- (v) Two numbers of black colour Mouse
- (vi) Two numbers of scanner
- (vii) Two numbers of key board
- (viii) Four numbers of paper roll
- (ix) One Dongle(USB stick)
- (x) Cash Rs-830/-

I, SI Nur Alam Siddik of Detective Department, SPC do hereby lodge this complaint against Md Makbul(36) s/o-Md Khalil of Jyotirmoy Colony near Rail gate PS-NJP Dist-Jalpaiguri and Ajoy Prasad of Lake Town under NJP PS area to the effect that on 03.08.21 at 16.00 hrs received an information that an online gambling is going on inside the room cum shop situated at Jyotirmoy Colony near Rail gate PS-NJP Dist-Jalpaiguri. Accordingly I informed the matter to ACP, D.D, SPC and as per his kind direction myself along with ASI, Abu Taleb, C/1054 Arobindo Roy, C/562 Utpal Saha all of D.D, SPC left for the spot to verify the veracity of information vide D.D, SPC GDE No. 16 dt-03.08.21

At 16.30 hrs on reaching the spot found that the above noted arrested accused person is playing online lottery through computer for prize through internet connection to some customers, seeing the police party the customers tried to flee away from the said shop. However we apprehended above noted arrested accused person namely Md Makbul(36) s/o-Md Khalil of Jyotirmoy Colony near Rail gate PS-NJP Dist-Jalpaiguri. On being asked the said person failed to produce any valid document in support of the said gambling using internet access. On being searched the spot the above noted gambling articles are found lying there. Accordingly I seized all the above noted articles in presence of witnesses namely (i) Sujan Barman s/o-Mrinal Barman of Jyotirmoy Colony PS-NJP Dist-Jalpaiguri (ii) Jagesh Mohanta s/o-Jagadish Mohanta of Thiknikata, Sushrutnagar PS- Matigara Dist-Darjeeling under proper seizure list. The seizure was made from 16.45 hrs to 17.45 hrs and arrested the above noted accused person after issuing memo of arrest and appraising the ground of arrest.

During interrogation the arrested accused person disclosed that the on line gambling was organized under the direction of one Ajoy Prasad of Lake Town under NJP PS and arrested accused Md Makbul(36) s/o-Md Khalil of Jyotirmoy Colony near Rail gate PS-NJP Dist-Jalpaiguri was working as an employee and he is the operator of online gambling. Arrested accused person confessed his guilt and stated that he along with one Ajoy Prasad of Lake Town under NJP PS have been running this illegal online lottery business for their wrongful gain.
