Introducing herewith three arrested accused persons namely i) Sanjoy Mittal(38) s/o-Raj Kumar Mittal of Back Side of NBMC&H,Kawakahali ,Susrutanagar PS-Matigara Dist-Darjeeling ii) Chanchal Adhikary(44) s/o-Lt Nihar Adhikary of Saktigarh near vegetable market ,w/n-31 PS-NJP Dist-Jalpaiguri iii)Manik Das(40) s/o-Dhiren Das of Takagach,PS-Pundibari Dist-Cooch A/P-Sitalapara PS-NJP Dist-Jalpaiguri along with the following articles under seizure:

- (i) One black colour Monitor (Dell)
- (ii) One black colour Monitor (LG)
- (iii) Two numbers of CPU(HP)
- (iv) Two numbers of printers white colour
- (v) Two numbers of black colour Mouse
- (vi) Two numbers of scanner
- (vii) Two numbers of key board
- (viii) Three numbers of paper roll
- (ix) One Dongle(USB stick)
- (x) Cash Rs-1190/-

I, SI Swadesh Saha of Detective Department, SPC do hereby lodge this complaint against i) Sanjoy Mittal(38) s/o-Raj Kumar Mittal of Back Side of NBMC&H,Kawakahali ,Susrutanagar PS-Matigara Dist-Darjeeling ii) Chanchal Adhikary(44) s/o-Lt Nihar Adhikary of Saktigarh near vegetable market ,w/n-31 PS-NJP Dist-Jalpaiguri iii)Manik Das(40) s/o-Dhiren Das of Takagach,PS-Pundibari Dist-Cooch A/P-Sitalapara PS-NJP Dist-Jalpaiguri and one Proloy Chakraborty of near Jhoogomali to the effect that on 03.08.21 at 16.00 hrs received an information that an online gambling is going on inside the room cum shop situated at Sitalapara ,w/n-31 under NJP PS. Accordingly I informed the matter to ACP,DD,SPC and as per his kind direction myself along with ASI,Praloy Bhattacharjee,C/682 LK Sabrat,CV-150 Bilash Ghosh all of D.D, SPC left for the spot to verify the veracity of information vide D.D,SPC GDE No. 17dt 03.08.21

At 16.35 hrs on reaching the spot found that the above noted accused persons are playing online lottery through computer for prize through internet connection to some customers, seeing the police party the customers tried to flee away from the said shop. However we apprehended three persons i) Sanjoy Mittal(38) s/o-Raj Kumar Mittal of Back Side of NBMC&H,Kawakahali ,Susrutanagar PS-Matigara Dist-Darjeeling ii) Chanchal Adhikary(44) s/o-Lt Nihar Adhikary of Saktigarh near vegetable market ,w/n-31 PS-NJP Dist-Jalpaiguri iii)Manik Das(40) s/o-Dhiren Das of Takagach,PS-Pundibari Dist-Cooch A/P-Sitalapara PS-NJP Dist-Jalpaiguri. On being asked the said persons failed to produce any valid document in support of the said gambling using internet access. On being searched the spot the above noted gambling articles are found lying there. Accordingly I seized all the above noted articles in presence of witnesses namely (i) Nikhil Mandol s/o-Natafor Mandol of Sitalapara,W/N-31 PS-NJP Dist-Jalpaiguri (ii) Rajib Ghosh s/o-Lt Madhusudhan Ghosh of Natunpara ,W/N-05 PS-Siliguri Dist-Darjeeling under proper seizure list. The seizure was made from 16.55 hrs to 17.50 hrs and arrested the above noted accused persons after issuing memo of arrest and appraising the ground of arrest.
