I S.I. Sushanta Dhar of Matigara P.S do hereby lodge a Complaint to the effect that on 07.08.2021 at 13:55 hrs I received a information from reliable source that 01 (One) Tractor bearing Reg. No. WB - 73 F 2327 loaded with river bed materials coming from Khaprail Bazar. On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Dimajote under Matigara P.S area, I found 01 (One) Tractor bearing Reg. No. WB - 73 F 2327 loaded with river bed materials going towards Matigara. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded trucks under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle under proper section of law and arrange for its investigation.
