

**SUB: Intimation regarding unauthorized handling of High Tension Line i.r.o Debidanga 11kV feeder from Purba Karaibari 33/11kV substation at Simulguri, Dakshin Palas, Champasari under Siliguri Town Division**

Sir,

I, Sri Soumyadeep Ganguly, S/O Sri Sibnath Ganguly, posted as Assistant Engineer (Tech), at Siliguri Town Division would like to inform you that it has come to our notice that one building is being constructed at **Simulguri, Dakshin Palas, Champasari** right under the live HT conductors of Debidanga 11kV feeder emanating from Purba Karaibari 33/11Kv substation flouting all safety norms. Upon inspection by the undersigned, the person claiming to have constructed the building identified himself as **Sri Bidhan Paul, Age: 48, S/O Brajendra Paul, Samarnagar, Boubazar, Dist.: Darjeeling**. As reported by Bidhan Paul himself, during building construction, Bidhan Paul with the help of building construction workers, erected three nos bamboo sticks with plastic insulations at the top to heighten the High Tension line passing over the building, thereby posing grave danger of electrocution to the general public coming in proximity to those bamboo sticks. Such kind of activity of handling our live network is totally Unauthorized & condemnable by law. You are therefore requested to take necessary action in this regard.

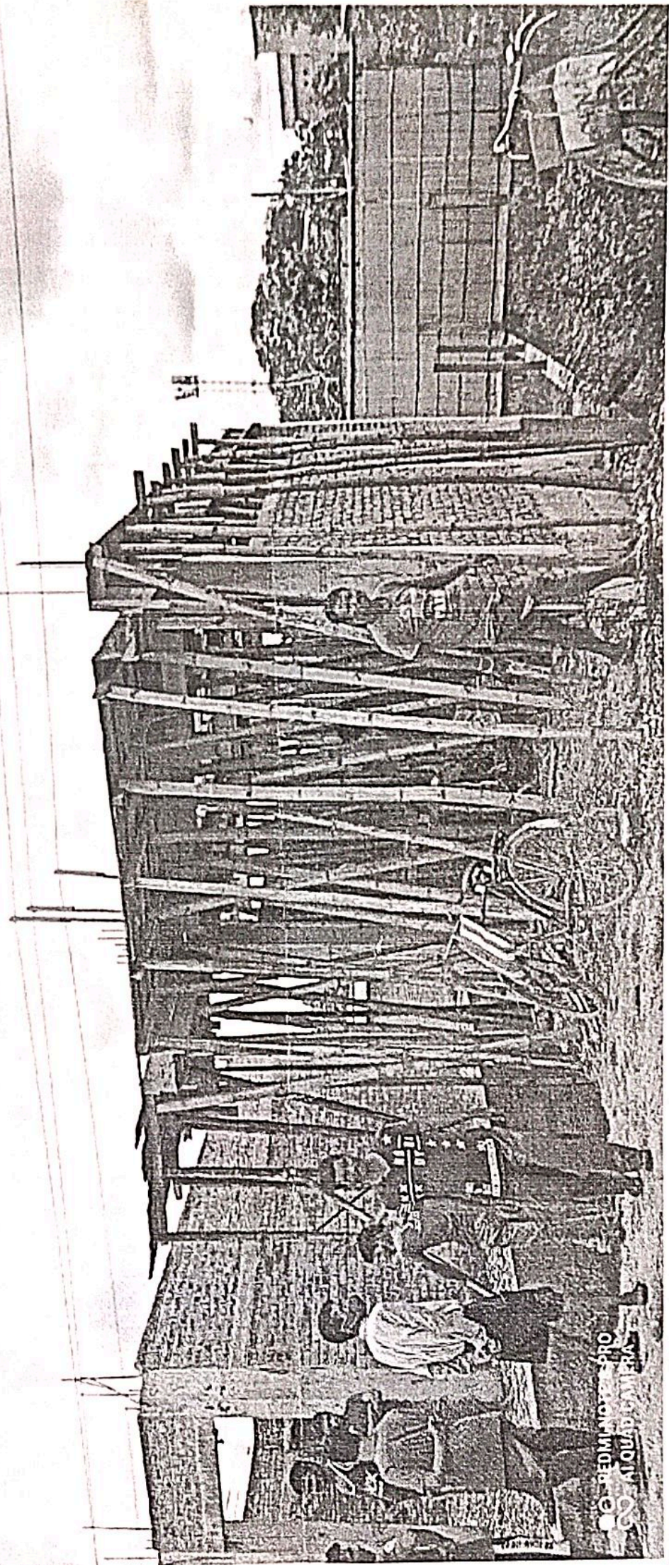
