Babita Sah D/o Sri Kashinath Sah, at that time, his said wife & (2) Rabi Sah @ Anil s/o Sri Kashinath Sah (3) Shivan Sah s/o Sri Kashinath Sah (4) Kashinath Sah s/o Not known (5) Smt. Sona Devi Sah w/o Sri Kashinath Sah (6) Kavita Kumari Sah D/o Sri Kashinath Sah, all are of above noted address at Bartala, Champusari, P.O & P.S - Pradhan Nagar, Distt - Darjeeling started abusing my brother Rajesh Kumar Sah, in filthy language and when he protested, they started beating him with fist & blows and said Rabi Sah @ Anil & Shivan Sah noted above caught him and spreaded his mouth by force and hit badly on his chest and injured him grievously, hence my brother, Rajesh Kumar Sah ~~was~~ admitted to Sreeji Distt. Hospital and still under treatment in serious condition, here.

After beating and assaulting my said brother the above named alleged persons stolen away a Gold chain and few 8000/- (Rupees Eight thousands from his pocket, and they have treated my brother, Rajesh Kumar Sah for due consequences.

So, Please take necessary action against above noted alleged persons.

The above statements are correctly written by me as per instructions of the complainant undersigned & read over & explained to him in detail.


