Sir,

In producing herewith one person namely Naresh Rai 36yrs s/o Dhan Bahadur Rai of Sukantapolly PS, Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure,

1. 07 (Seven) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
 2. 01 (One) Plastic Container containing 10 (Ten) litters local made country liquor marked as Exhibit "B" from which 01 litter randomly taken out as sample and marked as Exhibit "B-1",
 3. 07 (Seven) bottle Mc, Dewals No -1 celebration matured XXX Rum (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
- Total illicit liquor seized 15.560 litters.

I, ASI Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person namely Naresh Rai 36yrs s/o Dhan Bahadur Rai of Sukantapolly PS, Bagdogra, Dist- Darjeeling to the effect that today i.e, on 07.08.21 at around 18.15 hrs received a reliable source information that one house situated and located at Sukantapolly and they possessing and selling huge quantity of illicit liquor on his house which was located at Sukantapolly area to his designated customers. Accordingly, I shared the information with you and diarized the fact vide Bagdogra PS, GDE no 637 dtd, 07.08.2021 and as per your kind instruction, I along with Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singha, CV/ 375 Jogesh Barman all of Bagdogra PS, SPC, immediately rushed to the spot ie Sukantapolly area the house under Bagdogra PS, to work out the information. On reaching there at about 18.35 hrs, I contacted with my source and subsequently being pointed the shop seeing the police party some of customers run to fled away somehow we managed to apprehended the above noted person from the house on interrogation he admitted that he is the owner of said house and running the business since long. I called two local witnesses namely i) Santosh Singha s/o Narohari Singha of Bhujipani near Primary School ii) Koushik Mondal s/o Biswajit Mondal of near Gramin market both PS, Bagdogra Dist, Darjeeling disclosed them about the information and request them to remain present during search and seizure and they agreed to remain us and in presence of them we search the above noted house and the above noted huge quantity of illicit liquor has been recovered from his house which was storage and concealed on the house on demand Naresh Rai failed to produce any valid documents/papers in support of possessing and storing of huge quantity of the illicit liquor. Accordingly, I seized the above noted illicit liquor under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 18.45 hrs to 19.15 hrs. Total illicit liquor seized 15.560 litters.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against Naresh Rai 36yrs s/o Dhan Bahadur Rai of Sukantapolly PS, Bagdogra, Dist- Darjeeling and arrange for its investigation.
