Sir,

I Smt. Nima Lhamu Banerjee, wife of Gopal Banerjee, permanent residence of Coximpur Math, Burdwan presently residing at Paribar Apartment 2nd floor, Kanailal Batta Road, Haringpara, ward no. 15, P.O. Siliguri, P.S. Paritami Out post, Dist - Darjeeling, would like to bring to your kind notice regarding the following facts:

- 1) I was married to one Gopal Banerjee, s/o Sisir Banerjee, residence of Kantapur, Coximpur Math, P.O. Burdwan, W.B - 713101 as per Hindu rites and custom which was solemnized on 30/08/2006, out of said wedlock one female child was born on 6/08/2012 namely Ritika Banerjee @ Abrona Banerjee.
- 2) That my husband was in illicit affair with Soeta Sharmar and threatened me with dire consequences for being an obstacle in his relationship. Both of them arrived ^{in Darjeeling} from Burdwan on 1/08/2021 and on 3/08/2021 they came to Siliguri.
- 3) That on 4/08/21 at around 10pm my husband physically assaulted me and took away my phone and threw it in drain and also dragged me out of the house.
- 4) That due to his outrageous behavior I have also filed Matrimonial Suit being no. 62/2021 ~~and~~ in Additional District Court Siliguri and Misc. Case - CRT being no. 9/49/2020 in Additional Chief Judicial Magistrate, Siliguri.
- 5) That being a husband, he had never fulfilled his duties neither he has given any maintenance to support the family during the time of pandemic.

This letter with all his preceding tortures physical and mental above has crossed all limits and I have come to your good self to give me adequate protection so that I and my daughter can safely stay in our home and protect us from the torture committed upon us by Gopal Banerjee and also be kind to take appropriate actions against the said Gopal Banerjee as per the law.


