The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. Accounding, I arrested them u/s-41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
