In producing herewith eight (08) arrested accused persons who disclosed his name and identity as (i) Santosh Sha (30yrs) S/O- Lt Baijnath Sah of Tikiapara, Matangini Colony-I, Ward No-28, PS-Siliguri, Darjeeling (ii) Rohit Kumar (20yrs) S/O- Mangal Kumar of Lichubagan, Ward No-18, PS-Siliguri, Darjeeling (iii) Md Lalad (22yrs) S/O- Md Umer of Koila Depot, Ward No-7, PS-Siliguri, Darjeeling (iv) Rajib Guha (18yrs) S/O- Sankar Guha of Chittaranjan Colony, Bagrakote, Ward No-20, PS-Siliguri, Darjeeling (v) Ashim Bhattacharjee (29yrs) S/O- Amaldesh Bhattacharjee of Deshbandhupara, near Indoor Stadium, Ward No-29, PS-Siliguri, Darjeeling (vi) Anand Kumar (18yrs) S/O- Chulai Sah of C/O- S.C Mandal House, near Central Bank, Bhaktinagar, PS-NJP, Jalpaiguri (vii) Saheb Roy (23yrs) S/O- Dinesh Roy of Rabindranagar, Basic School, PS-Siliguri, Darjeeling (viii) Ajay Sutradhar (20yrs) S/O- Lt Moncranjan Sutradhar of Kundupukur Math, Ward No-38, PS-Bhaktinagar, Jalpaiguri. I, PSI Phurba Tendu Sherpa of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 05.08.2021 at around 19.40 hrs during my R/T Mobile Van duty, myself along with my accompanied force had been to Venus More, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before Police that, they were well aware of the pandemic situation and all the orders of Government as well as local administrations regarding COVID-19 as well as order of night curfew.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021, 753/III-ISS/2M-22/2020 dated 14.07.2021 and 753/IV-ISS/2M-22/2020 dated 29.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. According, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
