In producing herewith one arrested accused person namely Mangal Rajput (M-28) S/O-Lt Ram Avatar Rajput of- Gurung Busty, Ward No-3, PS Pradhan Nagar, Darjeeling along with seized articles (i) 25 (Twenty) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No-01.

I, ASI Ratan Ghosh of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 06/08/2021 at 08:15 hrs during morning RT mobile duty I received secret source information that, one person is carrying huge quantity of country spirit through Sevoke Road, near City Mall. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with C/702 Latifur Rahaman CV/1007 Jiten Roy left for PO to work out the information. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 25(Twenty five) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii)01 (One) Nylon Bag.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Gurung Busty and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 25 (Twenty five) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 08:35 hrs to 08:55 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 2500/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Mangal Rajput S/O-Lt Ram Avatar Rajput of- Gurung Busty, Ward No-3, PS Pradhan Nagar, Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
