, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Pradip Biswas (42) S/O Ashutosh Biswas of Sarbohara Colony ,Ward No. 28, PS- Siliguri, Dist-Darjeeling to the effect that on 06.08.21 at 20.05 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated Sarbohara Colony , Ward No. 28, PS- Siliguri, Dist- Darjeeling in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 385 dated 06.08.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with SI Hiru Kanti Sarkar, PSI Rajib Subba & CV/622 Ramanath Barman left for Sarbohara Colony , Ward No. 28 to verify the veracity of the information vide Siliguri PS GDE No. 386 dated 06.08.21. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.
