In producing here with the accused person namely Bibek Das (51/M) S/O Late Noni Gopal Das of Baribhasa, Sahudangi, PS-Newjalpaiguri, Dist-Jalpaiguri along with seized 15 (fifteen) bottles of Himalaya Gold 60up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 1500/- (Rs/- one thousand five hundred ) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I SI Sushanta Das of Khalpara TOP under PS Siliguri beg to report that today i.e. on 07.08.21 while performing special mobile van raid at 21:55 hrs. I received a telephonic information naka checking team at Jalpaimore that one person namely Bibek Das (51/M) S/O Late Noni Gopal Das of Baribhasa, Sahudangi, PS-Newjalpaiguri, Dist-Jalpaiguri is carry huge alcohol in the bag from airveiw more towers tinbati without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Jalpaimore Naka Checking point to verify the veracity of the information vide Khalpara TOP GDE No - 203, Dated: 06.08.21. After reaching Jalpaimore Naka Checking Point at 23.25 hrs naka team showing the above noted person, I interrogated the above noted person is he admitted guilt and caring the liquor secretly to different persons and seeing for illegal gain. Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During interrogation, I could recover the above noted alcohol from his possession. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 23:35 hrs to 23:55 hrs on 06.08.21.

Under the above noted fact and circumstances, I therefore, pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Bibek Das (51/M) S/O Late Noni Gopal Das of Baribhasa, Sahudangi, PS-Newjapaiguri, Dist-Jalpaiguri a for the possessing and selling alcohol illegally and arrange for its investigation.
